He further shows that the algebras constructed are examples of non-commutative crepant resolutions (NCCRs), in the sense of Van den Bergh, of Gorenstein affine toric threefolds. Some examples are Calabi-Yau and some are not. The author considers two types of 'consistency' conditions on dimer models, and shows that a 'geometrically consistent' dimer model is 'algebraically consistent'. He proves that the algebras obtained from algebraically consistent dimer models are 3-dimensional Calabi-Yau algebras. This is the key step which allows him to prove that these algebras are NCCRs of the Gorenstein affine toric threefolds associated to the dimer models.
