In addition, the Indonesia-UK Tropical Forest Management Programme started in 1992 and comprised a number of components related to fires as part of its overall improved forest management objective. After the 1997 fires numerous short- and long-term fire projects were proposed and started. Others, such as the first phase of the WWF project and the ADB's regional (RETA) and national (ADTA) projects, within a short time frame try to cover many aspects of fire problem such as socio-economic assessments, fire-fighting, area estimates, economic and policy assessments and ecological assessments. Representing a longer-term approach, CIFOR-ICRAF-UNESCO propose an in-depth study of the underlying causes and effects of fires. In addition to the international response Indonesia has several government agencies charged with the task of preventing, monitoring and controlling land and forest fires. Following the forest and land fires of 1994, the National Coordination Team for Land and Forest Fire Control was established in 1995. Interest in fire is only short-lived after a major fire event. Before the 1994 fires little attention was paid to the fire problem and missions mainly focussed on control and prevention of fires. Most of the new generation of fire projects established in 1997-98 address both issues.
