I learned so much from the applicants and the other committee members. I didn't know it then, but the committee was my ringside view of the small business financing process, including the dark side—collecting when clients defaulted and dealing with all the ugliness that prevails when a business goes bad. The vision for this book emerged after a particularly messy blood-fest when the lending committee wrote off several defaulted loans. In addition to entrepreneurs, this book was written so that venues teaching entrepreneurship can use it as a text book. In fact, I have been teaching entrepreneurship courses since 1997. This book was written to be a stand alone book, to support my business plan mentoring service (I review the worksheets for clients), and to be a text book for my course, How to Start, Grow and Manage a Business.
