CALIFORNIA OPERATES WITH A DECENTRALIZED LICENSING SYSTEM, MEANING THAT EACH CITY OR COUNTY MANAGES ITS OWN BUSINESS LICENSES. LOCATE THE RELEVANT GOVERNMENT WEBSITE FOR THE AREA WHERE THE BUSINESS OPERATES.

STEP 3: USE THE SEARCH TOOLS

ONCE ON THE LOCAL GOVERNMENT WEBSITE, LOOK FOR A SECTION DEDICATED TO BUSINESS LICENSES OR PERMITS. MANY SITES HAVE SEARCHABLE DATABASES WHERE YOU CAN INPUT THE INFORMATION GATHERED IN STEP 1. THIS WILL ALLOW YOU TO CHECK THE STATUS OF THE BUSINESS LICENSE.

STEP 4: CONTACT LOCAL AUTHORITIES

IF THE INFORMATION IS NOT AVAILABLE ONLINE, OR IF YOU REQUIRE FURTHER VERIFICATION, CONSIDER CONTACTING THE LOCAL LICENSING OFFICE DIRECTLY. THEY CAN PROVIDE ASSISTANCE AND CONFIRM THE STATUS OF THE BUSINESS LICENSE.
