One of these is a Home-Based Economic Activity (HBEA), e.g. sales of home-made snacks or car maintenance. The two groups organize their HBEA in very distinct ways. Differences between Suriname and Trinidad and Tobago are small. First of all economic growth has limited impact on assets and vulnerability of low-income groups. Moreover, policies aiming at stimulation of entrepreneurship such as micro-credit are relevant to classic entrepreneurs and not to the largegroup of security-seeking HBEA-operators.
