- **LIMITED LIABILITY COMPANY (LLC):** COMBINES THE BENEFITS OF A CORPORATION AND A PARTNERSHIP. OWNERS HAVE LIMITED LIABILITY WHILE ENJOYING FLEXIBLE MANAGEMENT OPTIONS.
