CERTIFIED WOMEN OWNED SMALL BUSINESSES (WOSBs) ARE ENTERPRISES THAT ARE AT LEAST 51% OWNED, OPERATED, AND CONTROLLED BY ONE OR MORE WOMEN. THIS CERTIFICATION CAN BE GRANTED BY VARIOUS ORGANIZATIONS, INCLUDING THE WOMEN'S BUSINESS ENTERPRISE NATIONAL COUNCIL (WBENC) AND THE SMALL BUSINESS ADMINISTRATION (SBA). THE PURPOSE OF THIS CERTIFICATION IS TO PROMOTE THE GROWTH OF WOMEN-OWNED BUSINESSES IN THE ECONOMY AND TO ENSURE EQUAL ACCESS TO OPPORTUNITIES THAT MAY BE AVAILABLE TO THEIR MALE COUNTERPARTS.

THE CERTIFICATION PROCESS INVOLVES A THOROUGH REVIEW OF THE BUSINESS'S STRUCTURE, OWNERSHIP, AND OPERATIONAL CONTROL TO ENSURE COMPLIANCE WITH THE ELIGIBILITY CRITERIA. - SMALL BUSINESS STATUS AS DEFINED BY THE SBA

THE APPLICATION PROCESS

THE APPLICATION PROCESS TYPICALLY INVOLVES GATHERING NECESSARY DOCUMENTATION, SUCH AS FINANCIAL STATEMENTS, BUSINESS LICENSES, AND PROOF OF OWNERSHIP. ONCE THE APPLICATION IS SUBMITTED, IT UNDERGOES A REVIEW PROCESS, WHICH MAY INCLUDE A SITE VISIT TO VERIFY THE INFORMATION PROVIDED.

CERTIFICATION MAINTENANCE
