## STEP 2: CONDUCT PRELIMINARY ONLINE SEARCHES

THE VIRGINIA STATE CORPORATION COMMISSION PROVIDES A SEARCHABLE DATABASE WHERE YOU CAN CHECK THE AVAILABILITY OF YOUR BUSINESS NAME. FOLLOW THESE STEPS:

1. VISIT THE VIRGINIA SCC WEBSITE.
2. NAVIGATE TO THE BUSINESS ENTITY SECTION.
3. USE THE ONLINE NAME AVAILABILITY SEARCH TOOL.
4. INPUT YOUR DESIRED BUSINESS NAME AND REVIEW THE RESULTS.

THIS DATABASE WILL INDICATE WHETHER THE NAME IS AVAILABLE, ALREADY IN USE, OR SIMILAR TO AN EXISTING NAME. IF YOUR NAME IS NOT AVAILABLE, CONSIDER MODIFYING IT OR BRAINSTORMING ALTERNATIVE OPTIONS.

## HOW TO RESERVE A BUSINESS NAME

IF YOU FIND A SUITABLE NAME THAT IS AVAILABLE, YOU MAY WANT TO RESERVE IT TO ENSURE THAT NO ONE ELSE CAN TAKE IT WHILE YOU PREPARE TO START YOUR BUSINESS. IN VIRGINIA, RESERVING A BUSINESS NAME INVOLVES THE FOLLOWING STEPS:

### STEP 1: COMPLETE A NAME RESERVATION APPLICATION

TO RESERVE YOUR BUSINESS NAME, COMPLETE THE NAME RESERVATION APPLICATION FORM AVAILABLE ON THE VIRGINIA SCC WEBSITE. THIS FORM REQUIRES YOU TO PROVIDE DETAILS ABOUT THE DESIRED NAME AND YOUR CONTACT INFORMATION.

## STEP 2: SUBMIT THE APPLICATION WITH PAYMENT

ONCE YOU HAVE COMPLETED THE APPLICATION FORM, SUBMIT IT ALONG WITH THE REQUIRED RESERVATION FEE. THE FEE IS TYPICALLY NOMINAL, BUT CHECK THE CURRENT RATES ON THE VIRGINIA SCC WEBSITE.

## STEP 3: AWAIT CONFIRMATION

AFTER SUBMITTING YOUR APPLICATION, YOU WILL RECEIVE CONFIRMATION FROM THE VIRGINIA SCC REGARDING YOUR NAME RESERVATION. THIS RESERVATION LASTS FOR A SPECIFIC PERIOD, USUALLY 120 DAYS, DURING WHICH YOU CAN PROCEED WITH YOUR BUSINESS FORMATION.
