CORPORATION

A CORPORATION IS A LEGAL ENTITY SEPARATE FROM ITS OWNERS, PROVIDING THE HIGHEST LEVEL OF LIABILITY PROTECTION. IT IS MORE COMPLEX TO SET UP AND REQUIRES ADHERENCE TO STRICTER REGULATIONS AND FORMALITIES.

HOW TO OBTAIN A CERTIFICATE OF REGISTRATION
