UNDERSTANDING COURIER BUSINESS STRUCTURES

SOLE PROPRIETORSHIP

LIMITED LIABILITY COMPANY (LLC)

AN LLC COMBINES THE BENEFITS OF A CORPORATION AND A PARTNERSHIP. IT PROTECTS PERSONAL ASSETS FROM BUSINESS LIABILITIES AND OFFERS FLEXIBILITY IN MANAGEMENT AND TAXATION. THIS IS OFTEN THE PREFERRED STRUCTURE FOR MANY COURIER BUSINESSES.

CORPORATION

A CORPORATION IS A MORE COMPLEX STRUCTURE THAT PROVIDES THE HIGHEST LEVEL OF PERSONAL LIABILITY PROTECTION. HOWEVER, IT REQUIRES MORE PAPERWORK AND IS SUBJECT TO DOUBLE TAXATION. CORPORATIONS MIGHT BE SUITABLE FOR LARGER COURIER BUSINESSES WITH SIGNIFICANT ASSETS.

LEGAL REQUIREMENTS FOR COURIER BUSINESSES
