UNDERSTANDING FICTITIOUS BUSINESS NAMES

DEFINITION AND PURPOSE

A FICTITIOUS BUSINESS NAME (FBN), ALSO KNOWN AS A "DOING BUSINESS AS" (DBA) NAME, IS AN ALIAS USED BY A BUSINESS THAT DIFFERS FROM ITS LEGAL NAME. THIS PRACTICE ALLOWS BUSINESSES TO OPERATE UNDER A NAME THAT MAY BETTER REPRESENT THEIR PRODUCTS OR SERVICES.

LEGAL REQUIREMENTS

IN CALIFORNIA, ANY BUSINESS OPERATING UNDER A NAME THAT IS NOT ITS LEGAL NAME MUST FILE FOR A FICTITIOUS BUSINESS NAME STATEMENT. THIS REQUIREMENT HELPS TO MAINTAIN TRANSPARENCY IN THE MARKETPLACE AND PROTECT CONSUMERS. WHEN BUSINESSES REGISTER THEIR FBNs, IT PROVIDES A PUBLIC RECORD, WHICH CAN HELP IN BUILDING TRUST WITH CLIENTS AND CUSTOMERS.
