UNDERSTANDING THE BASICS OF MILEAGE DEDUCTION

DEDUCTING MILES FOR BUSINESS INVOLVES CLAIMING A TAX DEDUCTION FOR THE MILES DRIVEN FOR BUSINESS PURPOSES. THE IRS ALLOWS BUSINESS OWNERS AND SELF-EMPLOYED INDIVIDUALS TO DEDUCT THESE MILES, WHICH CAN LEAD TO A SUBSTANTIAL REDUCTION IN TAXABLE INCOME. TO QUALIFY FOR A MILEAGE DEDUCTION, THE TRAVEL MUST BE NECESSARY AND ORDINARY FOR YOUR BUSINESS OPERATIONS. METHODS OF CALCULATING MILEAGE DEDUCTIONS

WHEN IT COMES TO DEDUCTING MILES FOR BUSINESS, THE IRS OFFERS TWO PRIMARY METHODS FOR CALCULATING YOUR DEDUCTIONS: THE STANDARD MILEAGE RATE METHOD AND THE ACTUAL EXPENSE METHOD. EACH METHOD HAS ITS OWN ADVANTAGES AND DISADVANTAGES, AND SELECTING THE RIGHT ONE DEPENDS ON YOUR SPECIFIC SITUATION.

STANDARD MILEAGE RATE METHOD

THE STANDARD MILEAGE RATE IS A SIMPLIFIED METHOD THAT ALLOWS TAXPAYERS TO MULTIPLY THEIR BUSINESS MILES DRIVEN BY A PREDETERMINED RATE SET BY THE IRS. FOR THE TAX YEAR 2023, THIS RATE IS 65.5 CENTS PER MILE. THIS METHOD IS STRAIGHTFORWARD AND REQUIRES MINIMAL RECORD-KEEPING, MAKING IT A POPULAR CHOICE AMONG BUSINESS OWNERS.

ACTUAL EXPENSE METHOD

THE ACTUAL EXPENSE METHOD ALLOWS YOU TO DEDUCT THE ACTUAL COSTS ASSOCIATED WITH OPERATING YOUR VEHICLE FOR BUSINESS PURPOSES. THIS INCLUDES:

- FUEL
- OIL CHANGES
- REPAIRS
- DEPRECIATION
- INSURANCE
- REGISTRATION FEES
- LEASE PAYMENTS (IF LEASING THE VEHICLE)

WHILE THIS METHOD CAN YIELD A LARGER DEDUCTION FOR SOME TAXPAYERS, IT REQUIRES MORE DETAILED DOCUMENTATION AND RECORD-KEEPING. BUSINESS OWNERS MUST TRACK ALL EXPENSES AND ALLOCATE THEM ACCORDINGLY TO BUSINESS USE VERSUS PERSONAL USE.

IRS GUIDELINES FOR BUSINESS MILEAGE

THE IRS HAS SPECIFIC GUIDELINES THAT DICTATE HOW MILEAGE DEDUCTIONS SHOULD BE CALCULATED AND CLAIMED. IT IS ESSENTIAL TO FAMILIARIZE YOURSELF WITH THESE RULES TO ENSURE COMPLIANCE AND MAXIMIZE YOUR DEDUCTIONS.

QUALIFYING MILES

NOT ALL MILES DRIVEN ARE ELIGIBLE FOR DEDUCTION. QUALIFYING BUSINESS MILEAGE INCLUDES:

- TRAVEL TO MEET CLIENTS OR CUSTOMERS
- TRAVEL TO BUSINESS-RELATED MEETINGS
- TRAVEL TO PICK UP SUPPLIES OR PRODUCTS
- TRAVEL TO TEMPORARY WORK LOCATIONS

IN CONTRAST, THE FOLLOWING TYPES OF TRAVEL ARE NOT DEDUCTIBLE:

- COMMUTING FROM HOME TO YOUR REGULAR WORKPLACE
- PERSONAL ERRANDS

- TRAVEL FOR NON-BUSINESS-RELATED ACTIVITIES

How to Document Your Mileage

ACCURATE DOCUMENTATION IS VITAL WHEN IT COMES TO DEDUCTING MILES FOR BUSINESS. THE IRS REQUIRES THAT TAXPAYERS MAINTAIN A DETAILED RECORD OF THEIR BUSINESS MILEAGE TO SUBSTANTIATE THEIR CLAIMS. HERE ARE SOME BEST PRACTICES FOR DOCUMENTING YOUR MILEAGE:

- KEEP A MILEAGE LOG: RECORD EACH TRIP, INCLUDING THE DATE, DESTINATION, PURPOSE, AND NUMBER OF MILES DRIVEN.

Q: WHAT IS THE CURRENT STANDARD MILEAGE RATE FOR BUSINESS IN 2023?

A: THE STANDARD MILEAGE RATE FOR BUSINESS IN 2023 IS 65.5 CENTS PER MILE, AS SET BY THE IRS.

Q: CAN I DEDUCT MY COMMUTING MILES?

A: NO, COMMUTING MILES BETWEEN YOUR HOME AND YOUR REGULAR WORKPLACE ARE NOT DEDUCTIBLE. HOWEVER, TRAVEL TO TEMPORARY WORK LOCATIONS OR CLIENT MEETINGS MAY QUALIFY.

Q: WHAT RECORDS DO I NEED TO MAINTAIN FOR MILEAGE DEDUCTIONS?

A: YOU SHOULD MAINTAIN A MILEAGE LOG THAT INCLUDES THE DATE, DESTINATION, PURPOSE, AND DISTANCE TRAVELED FOR EACH BUSINESS TRIP, ALONG WITH ANY RELATED RECEIPTS IF USING THE ACTUAL EXPENSE METHOD.

Q: CAN I SWITCH BETWEEN THE STANDARD MILEAGE RATE AND ACTUAL EXPENSE METHODS?

A: YES, YOU CAN SWITCH BETWEEN THE TWO METHODS, BUT THERE ARE SPECIFIC RULES. IF YOU CLAIM THE ACTUAL EXPENSES FOR A VEHICLE IN THE FIRST YEAR, YOU CANNOT SWITCH TO THE STANDARD MILEAGE RATE FOR THAT VEHICLE IN SUBSEQUENT YEARS.

Q: ARE THERE ANY APPS THAT CAN HELP TRACK MY MILEAGE?

A: YES, THERE ARE SEVERAL MILEAGE TRACKING APPS AVAILABLE THAT CAN AUTOMATICALLY LOG YOUR TRIPS AND HELP MAINTAIN ACCURATE RECORDS FOR TAX PURPOSES, MAKING THE PROCESS MORE EFFICIENT.

Q: WHAT IF I FORGET TO RECORD SOME MILEAGE?

A: WHILE IT IS ESSENTIAL TO KEEP ACCURATE RECORDS, IF YOU FORGET TO LOG SOME MILEAGE, YOU CAN ESTIMATE BASED ON YOUR OTHER LOGS. HOWEVER, THE IRS PREFERS DETAILED RECORDS, SO IT IS BEST TO BE DILIGENT IN TRACKING ALL BUSINESS-RELATED TRAVEL.

Q: CAN I DEDUCT MILEAGE FOR VOLUNTEER WORK?

A: NO, THE IRS DOES NOT ALLOW DEDUCTIONS FOR MILES DRIVEN WHILE VOLUNTEERING FOR CHARITABLE ORGANIZATIONS. HOWEVER, YOU MAY BE ABLE TO DEDUCT CERTAIN OUT-OF-POCKET EXPENSES INCURRED WHILE VOLUNTEERING.

Q: WHAT IF I USE MY VEHICLE FOR BOTH PERSONAL AND BUSINESS PURPOSES?

A: IF YOU USE YOUR VEHICLE FOR BOTH PERSONAL AND BUSINESS PURPOSES, YOU CAN ONLY DEDUCT THE MILES DRIVEN SPECIFICALLY FOR BUSINESS. IT'S IMPORTANT TO KEEP DETAILED RECORDS TO DISTINGUISH BETWEEN THE TWO.
