TYPES OF DOCTORATE OF BUSINESS PROGRAMS

DOCTORATE OF BUSINESS PROGRAMS PRIMARILY COME IN TWO FORMS: THE DOCTOR OF BUSINESS ADMINISTRATION (DBA) AND THE PH.D. IN BUSINESS. EACH PROGRAM SERVES DIFFERENT PURPOSES AND IS SUITED FOR DISTINCT CAREER PATHS.

DOCTOR OF BUSINESS ADMINISTRATION (DBA)

THE DBA PROGRAM IS DESIGNED FOR EXPERIENCED PROFESSIONALS WHO WISH TO APPLY THEORETICAL KNOWLEDGE TO PRACTICAL BUSINESS CHALLENGES. IT EMPHASIZES REAL-WORLD APPLICATIONS AND IS OFTEN PURSUED BY THOSE ALREADY IN LEADERSHIP POSITIONS. DBA CANDIDATES TYPICALLY WORK ON PROJECTS THAT ADDRESS SPECIFIC ISSUES WITHIN THEIR ORGANIZATIONS, UTILIZING A MIX OF QUALITATIVE AND QUANTITATIVE RESEARCH METHODS.

PH.D. IN BUSINESS

IN CONTRAST, THE PH.D. IN BUSINESS IS MORE RESEARCH-FOCUSED AND IS AIMED AT INDIVIDUALS WHO ASPIRE TO CONTRIBUTE ORIGINAL KNOWLEDGE TO THE FIELD THROUGH EXTENSIVE RESEARCH. THIS PROGRAM IS IDEAL FOR THOSE LOOKING TO ENTER ACADEMIA, ENGAGE IN HIGH-LEVEL RESEARCH, OR TEACH AT UNIVERSITIES. PH.D. CANDIDATES USUALLY CONDUCT IN-DEPTH STUDIES AND PUBLISH THEIR FINDINGS IN ACADEMIC JOURNALS.

PROFESSIONAL EXPERIENCE

APPLICANTS ARE TYPICALLY EXPECTED TO HAVE SEVERAL YEARS OF PROFESSIONAL EXPERIENCE, ESPECIALLY FOR DBA PROGRAMS. THIS EXPERIENCE SHOULD DEMONSTRATE A TRACK RECORD OF LEADERSHIP AND CONTRIBUTIONS TO THE FIELD.

STANDARDIZED TESTS

MANY PROGRAMS REQUIRE SCORES FROM STANDARDIZED TESTS SUCH AS THE GMAT OR GRE, ALTHOUGH SOME INSTITUTIONS MAY WAIVE THIS REQUIREMENT FOR EXPERIENCED PROFESSIONALS.

PERSONAL STATEMENT AND RECOMMENDATIONS

A PERSONAL STATEMENT OUTLINING THE APPLICANT'S GOALS AND MOTIVATIONS FOR PURSUING A DOCTORATE IS USUALLY REQUIRED. ADDITIONALLY, LETTERS OF RECOMMENDATION FROM PROFESSIONAL OR ACADEMIC REFERENCES ARE COMMON.
