On historic Route 66 in Southern California, the city of 215,000 was once a bustling bedroom community -- the 1950s birthplace of McDonald's and a 1970s All-America City. But the thousands of jobs lost after the closing of Kaiser Steel in the mid-1980s and Norton Air Force Base in 1994 (about 10,000 jobs) rippled through the area's blue-collar workforce to devastating effect. We never recovered, says Marlene Merrill of the county's Community Action Program, which gets 20,000 calls a month from residents seeking help. The real-estate bubble in the late 1990s and early 2000s fueled a partial resurgence in construction and service jobs, but when the boom went bust, those jobs did, too. Ramirez works for her welfare check, supervising the distribution of
