EMPHASIZING VALUE PROPOSITION

IT IS CRUCIAL TO REITERATE YOUR UNIQUE VALUE PROPOSITION. THIS MEANS CLEARLY STATING WHAT SETS YOUR BUSINESS APART FROM COMPETITORS. FOCUS ON:

- DIFFERENTIATING FACTORS: IDENTIFY ANY UNIQUE ASPECTS OF YOUR SERVICE OR PRODUCT THAT FULFILL THE CLIENT'S NEEDS BETTER THAN ALTERNATIVES.
- PROOF OF SUCCESS: INCLUDE ANY STATISTICS OR TESTIMONIALS THAT DEMONSTRATE YOUR PAST SUCCESSES AND RELIABILITY.

TONE AND PROFESSIONALISM

CRAFTING AN EFFECTIVE CALL TO ACTION

Struggles over the Kern River's water established one of the most important concepts in water law in some parts of the United States—that prior appropriation, dependent on the chronological order of diversions from waterways, could legally coexist with riparian rights, which restrict water usage to landownership directly next to a river or stream. Littlefield traces this concept to the 1886 California Supreme Court case of *Lux v. Haggin*—which pitted the giant farming and cattle company of Miller & Lux against a prominent land baron, James B. Haggin—and shows how the lawsuit profoundly shaped future waters issues, which in turn influenced water laws in other western states that were grappling with similar questions. Far from a dry legal history, Ruling the Waters tells a story with world-wide historical environmental ramifications, a tale of competing personalities and values and visions that forever changed both the economy and the ecology of the American West.
