UNDERSTANDING FICTITIOUS BUSINESS NAMES

A FICTITIOUS BUSINESS NAME IS A NAME UNDER WHICH A BUSINESS OPERATES THAT IS DIFFERENT FROM ITS LEGAL BUSINESS NAME. IMPORTANCE OF FICTITIOUS BUSINESS NAMES
