- **SOLE PROPRIETORSHIPS:** THIS IS THE SIMPLEST FORM OF BUSINESS ENTITY, WHERE ONE INDIVIDUAL OWNS AND OPERATES THE BUSINESS. THE OWNER IS PERSONALLY LIABLE FOR ALL DEBTS AND OBLIGATIONS.

HOW TO PERFORM A FLORIDA BUSINESS ENTITY SEARCH
