UNDERSTANDING FLORIDA DBA

THE TERM "DOING BUSINESS AS" (DBA) REFERS TO A REGISTERED NAME THAT A BUSINESS USES TO OPERATE THAT DIFFERS FROM ITS LEGAL NAME. IN FLORIDA, A DBA IS ALSO KNOWN AS A FICTITIOUS NAME. THIS REGISTRATION IS NECESSARY FOR BUSINESSES THAT WISH TO PROMOTE THEMSELVES UNDER A DIFFERENT NAME, PROVIDING AN AVENUE FOR BRANDING AND MARKETING FLEXIBILITY. FOR EXAMPLE, IF JOHN SMITH OPERATES A LANDSCAPING BUSINESS UNDER HIS NAME, HE MIGHT CHOOSE TO REGISTER A DBA FOR "SMITH'S LANDSCAPING" TO CREATE A MORE MARKETABLE IDENTITY.

REGISTERING A DBA IN FLORIDA IS NOT JUST A BRANDING STRATEGY; IT IS LEGALLY REQUIRED FOR SOLE PROPRIETORS AND PARTNERSHIPS THAT OPERATE UNDER A NAME THAT DOES NOT INCLUDE THE OWNER'S LAST NAME. CORPORATIONS AND LIMITED LIABILITY COMPANIES (LLCS) MUST ALSO FILE FOR A DBA IF THEY CHOOSE TO DO BUSINESS UNDER A NAME THAT IS NOT THEIR REGISTERED NAME. THIS PROCESS HELPS ENSURE CONSUMER PROTECTION AND PREVENTS FRAUD BY KEEPING BUSINESS PRACTICES TRANSPARENT.

1. VISIT THE FLORIDA DIVISION OF CORPORATIONS WEBSITE.

STEP 3: CHECK ADDITIONAL DATABASES

STEP 4: REGISTER THE DBA

IF THE NAME IS AVAILABLE, THE NEXT STEP IS TO FILE FOR REGISTRATION. THIS CAN TYPICALLY BE DONE ONLINE OR THROUGH A PAPER APPLICATION. THE FILING PROCESS USUALLY REQUIRES THE FOLLOWING:

- THE DESIRED FICTITIOUS NAME.
- THE NAME AND ADDRESS OF THE BUSINESS OWNER(S).
- A FILING FEE, WHICH VARIES BY COUNTY.

TRADEMARK DATABASES

UTILIZING TRADEMARK DATABASES, SUCH AS THE UNITED STATES PATENT AND TRADEMARK OFFICE (USPTO), CAN ALSO BE BENEFICIAL. THIS SEARCH WILL HELP ENSURE THAT THE DESIRED NAME DOES NOT INFRINGE ON ANY FEDERALLY REGISTERED TRADEMARKS.

COMMON QUESTIONS ABOUT FLORIDA DBA

Q: WHAT HAPPENS IF MY DESIRED DBA NAME IS ALREADY TAKEN?

A: YES, DBA NAMES IN FLORIDA CANNOT BE MISLEADING OR IMPLY A FALSE ASSOCIATION WITH GOVERNMENT ENTITIES. ADDITIONALLY, CERTAIN WORDS, SUCH AS "BANK" OR "INSURANCE," MAY REQUIRE SPECIAL APPROVAL.

Q: CAN AN LLC OR CORPORATION USE A DBA?

A: YES, BOTH LLCs AND CORPORATIONS CAN REGISTER A DBA TO OPERATE UNDER A DIFFERENT NAME THAN THEIR LEGAL BUSINESS NAME, PROVIDED THEY COMPLETE THE NECESSARY REGISTRATION PROCESS.
