TYPES OF BUSINESS TAXES IN FORT LAUDERDALE

IN FORT LAUDERDALE, BUSINESSES ARE SUBJECT TO SEVERAL TYPES OF TAXES. UNDERSTANDING THESE TAXES IS CRUCIAL FOR COMPLIANCE AND EFFECTIVE FINANCIAL MANAGEMENT. THE PRIMARY TAXES THAT AFFECT BUSINESSES INCLUDE:

1. CORPORATE INCOME TAX

FLORIDA IMPOSES A SALES TAX ON THE SALE OF GOODS AND CERTAIN SERVICES. THE STATE SALES TAX RATE IS 6%, BUT LOCAL GOVERNMENTS CAN LEVY ADDITIONAL TAXES, RESULTING IN A COMBINED RATE THAT CAN BE HIGHER. IN FORT LAUDERDALE, THE TOTAL SALES TAX RATE IS CURRENTLY 7%. BUSINESSES MUST COLLECT THIS TAX FROM CUSTOMERS AND REMIT IT TO THE STATE.

3. PROPERTY TAX

PROPERTY TAXES ARE ASSESSED ON REAL PROPERTY OWNED BY BUSINESSES, INCLUDING COMMERCIAL BUILDINGS AND LAND. THE PROPERTY TAX RATE VARIES DEPENDING ON THE PROPERTY'S LOCATION AND ITS ASSESSED VALUE. PROPERTY TAXES ARE A SIGNIFICANT EXPENSE FOR MANY BUSINESSES IN FORT LAUDERDALE, AND IT IS ESSENTIAL TO STAY INFORMED ABOUT LOCAL ASSESSMENTS AND EXEMPTIONS.

4. EMPLOYER TAXES

TAX RATES AND REGULATIONS
