TYPES OF HEALTH INSURANCE PLANS

SMALL BUSINESSES IN MARYLAND HAVE SEVERAL OPTIONS WHEN IT COMES TO HEALTH INSURANCE PLANS. THE MOST COMMON TYPES INCLUDE:

- **EXCLUSIVE PROVIDER ORGANIZATION (EPO):** EPO PLANS ARE SIMILAR TO PPOs BUT DO NOT COVER ANY OUT-OF-NETWORK CARE EXCEPT IN EMERGENCIES. THEY TEND TO HAVE LOWER PREMIUMS THAN PPOs.
- **HIGH DEDUCTIBLE HEALTH PLANS (HDHP):** HDHPs HAVE HIGHER DEDUCTIBLES AND LOWER PREMIUMS. THEY ARE OFTEN PAIRED WITH HEALTH SAVINGS ACCOUNTS (HSAs), ALLOWING EMPLOYEES TO SAVE FOR MEDICAL EXPENSES TAX-FREE.

EACH TYPE OF PLAN HAS ITS OWN ADVANTAGES AND DISADVANTAGES, WHICH CAN AFFECT THE OVERALL COST AND QUALITY OF CARE FOR EMPLOYEES.

ADDITIONAL COVERAGE OPTIONS

IN ADDITION TO THE PRIMARY TYPES OF HEALTH INSURANCE PLANS, SMALL BUSINESSES CAN ALSO EXPLORE:

LEGAL REQUIREMENTS FOR HEALTH INSURANCE

AFFORDABLE CARE ACT (ACA) COMPLIANCE

UNDER THE AFFORDABLE CARE ACT (ACA), SMALL BUSINESSES IN MARYLAND WITH 50 OR MORE FULL-TIME EQUIVALENT EMPLOYEES ARE REQUIRED TO OFFER HEALTH INSURANCE TO THEIR EMPLOYEES OR FACE PENALTIES. HOWEVER, BUSINESSES WITH FEWER THAN 50 EMPLOYEES ARE NOT MANDATED TO PROVIDE HEALTH COVERAGE BUT MAY STILL CHOOSE TO DO SO TO ATTRACT AND RETAIN TALENT.

MARYLAND-SPECIFIC REGULATIONS

MARYLAND HAS ITS OWN SET OF REGULATIONS CONCERNING HEALTH INSURANCE FOR SMALL BUSINESSES. SMALL BUSINESSES SHOULD BE AWARE OF:

- **SMALL GROUP MARKET REQUIREMENTS:** IN MARYLAND, HEALTH INSURANCE PLANS FOR SMALL GROUPS (1-50 EMPLOYEES) MUST COVER ESSENTIAL HEALTH BENEFITS AND CANNOT IMPOSE ANNUAL OR LIFETIME LIMITS ON COVERAGE.
- **GUARANTEED ISSUE AND RENEWABILITY:** ALL SMALL BUSINESSES ARE ENTITLED TO GUARANTEED ISSUE OF HEALTH INSURANCE POLICIES, MEANING INSURERS CANNOT REFUSE COVERAGE BASED ON HEALTH STATUS.
- **RATE RESTRICTIONS:** INSURERS IN MARYLAND CANNOT CHARGE HIGHER PREMIUMS BASED SOLELY ON HEALTH STATUS, AGE, OR GENDER, ENSURING FAIR PRICING.
