UNDERSTANDING HEALTH INSURANCE OPTIONS

TYPES OF HEALTH INSURANCE PLANS

- **HIGH DEDUCTIBLE HEALTH PLANS (HDHPs):** THESE PLANS HAVE HIGHER DEDUCTIBLES AND LOWER PREMIUMS, MAKING THEM A COST-EFFECTIVE OPTION FOR SOME BUSINESSES. THEY CAN BE PAIRED WITH HEALTH SAVINGS ACCOUNTS (HSAs) TO HELP EMPLOYEES MANAGE OUT-OF-POCKET EXPENSES.
- **EMPLOYEE ASSISTANCE PROGRAMS (EAPs):** WHILE NOT TRADITIONAL HEALTH INSURANCE, EAPs PROVIDE ADDITIONAL

SUPPORT SERVICES, INCLUDING MENTAL HEALTH COUNSELING AND LEGAL ASSISTANCE, WHICH CAN BE VALUABLE FOR EMPLOYEES.

UNDERSTANDING THESE OPTIONS WILL ENABLE SMALL BUSINESS OWNERS TO TAILOR THEIR OFFERINGS TO THE NEEDS OF THEIR WORKFORCE WHILE ALSO CONSIDERING COST IMPLICATIONS.
