UNDERSTANDING COOPERATIVES

COOPERATIVES ARE BUSINESSES OWNED AND OPERATED BY A GROUP OF MEMBERS FOR THEIR MUTUAL BENEFIT. THE SEVEN COOPERATIVE PRINCIPLES OUTLINED BY THE INTERNATIONAL COOPERATIVE ALLIANCE INCLUDE VOLUNTARY AND OPEN MEMBERSHIP, DEMOCRATIC MEMBER CONTROL, MEMBER ECONOMIC PARTICIPATION, AUTONOMY AND INDEPENDENCE, EDUCATION, TRAINING, AND INFORMATION, COOPERATION AMONG COOPERATIVES, AND CONCERN FOR COMMUNITY. UNDERSTANDING THESE PRINCIPLES IS ESSENTIAL FOR ANYONE INTERESTED IN STARTING A COOPERATIVE BUSINESS.

TYPES OF COOPERATIVES

WORKER COOPERATIVES ARE OWNED AND OPERATED BY THE EMPLOYEES. MEMBERS SHARE IN THE PROFITS AND HAVE A SAY IN THE DECISION-MAKING PROCESSES, MAKING THIS MODEL PARTICULARLY APPEALING TO THOSE SEEKING FAIR LABOR PRACTICES.

PRODUCER COOPERATIVES

PRODUCER COOPERATIVES CONSIST OF INDEPENDENT PRODUCERS OR FARMERS WHO COME TOGETHER TO ENHANCE THEIR MARKET POWER. THIS TYPE OFTEN FOCUSES ON MARKETING AND DISTRIBUTING THEIR PRODUCTS COLLECTIVELY.

HOUSING COOPERATIVES

HOUSING COOPERATIVES ARE FORMED WHEN INDIVIDUALS COME TOGETHER TO OWN AND MANAGE RESIDENTIAL PROPERTIES. MEMBERS SHARE THE COSTS ASSOCIATED WITH THE PROPERTY AND HAVE A SAY IN ITS MANAGEMENT, PROMOTING AFFORDABLE HOUSING SOLUTIONS.

FORMING A COOPERATIVE

THE PROCESS OF FORMING A COOPERATIVE INVOLVES SEVERAL KEY STEPS, FROM ORGANIZING YOUR GROUP TO ESTABLISHING A LEGAL ENTITY.

CREATING A BUSINESS PLAN

A WELL-STRUCTURED BUSINESS PLAN IS ESSENTIAL FOR ANY COOPERATIVE. THE PLAN SHOULD OUTLINE YOUR COOPERATIVE'S MISSION, VISION, GOALS, AND OPERATIONAL STRATEGIES. IT SHOULD ALSO INCLUDE FINANCIAL PROJECTIONS AND MARKETING STRATEGIES TO ATTRACT MEMBERS AND CUSTOMERS.

INCORPORATING THE COOPERATIVE
