REGIONAL SALARY VARIATIONS

NORTH AMERICA

IN THE UNITED STATES AND CANADA, SALARIES FOR INTERNATIONAL BUSINESS PROFESSIONALS ARE AMONG THE HIGHEST GLOBALLY. FOR INSTANCE, ENTRY-LEVEL POSITIONS MAY EARN BETWEEN \$60,000 TO \$80,000, WHILE EXPERIENCED MANAGERS CAN EARN WELL OVER \$120,000 ANNUALLY.

EUROPE

WESTERN EUROPEAN COUNTRIES SUCH AS GERMANY, THE UK, AND FRANCE OFFER COMPETITIVE SALARIES, THOUGH THEY MAY VARY SIGNIFICANTLY. FOR EXAMPLE, A PROJECT MANAGER IN LONDON CAN EARN AROUND £70,000 ANNUALLY, WHILE SIMILAR ROLES IN EASTERN EUROPE MAY OFFER LOWER COMPENSATION.

AN INTERNATIONAL BUSINESS MANAGER IN SINGAPORE CAN EXPECT TO EARN BETWEEN \$90,000 TO \$150,000.

SALARY EXPECTATIONS BY ROLE
