HISTORICAL CONTEXT OF NATIVE AMERICANS IN BUSINESS

THE HISTORY OF NATIVE AMERICANS IN BUSINESS IS DEEPLY INTERTWINED WITH THE BROADER NARRATIVE OF AMERICAN ECONOMIC DEVELOPMENT. POLICIES IMPOSED BY THE U.S. GOVERNMENT OFTEN RESTRICTED NATIVE AMERICAN ECONOMIC ACTIVITIES, LEADING TO ECONOMIC DISENFRANCHISEMENT. IT WASN'T UNTIL THE LATE 20TH CENTURY THAT SIGNIFICANT EFFORTS WERE MADE TO REVITALIZE NATIVE AMERICAN ENTREPRENEURSHIP. LEGISLATIVE CHANGES, SUCH AS THE INDIAN SELF-DETERMINATION AND EDUCATION ASSISTANCE ACT OF 1975, LAID THE GROUNDWORK FOR GREATER AUTONOMY AND ECONOMIC DEVELOPMENT WITHIN NATIVE COMMUNITIES.

CHALLENGES FACED BY NATIVE AMERICAN ENTREPRENEURS

LACK OF ACCESS TO CAPITAL
