THIS HELPS CONSUMERS IDENTIFY THE ACTUAL OWNER OF THE BUSINESS AND ADDS A LAYER OF TRANSPARENCY.

## CORPORATE NAMES

CORPORATE NAMES ARE THE OFFICIAL NAMES OF CORPORATIONS AND MUST BE UNIQUE AND DISTINGUISHABLE FROM OTHER REGISTERED ENTITIES IN NEW JERSEY. WHEN FORMING A CORPORATION, YOU MUST CHOOSE A NAME THAT COMPLIES WITH THE NEW JERSEY BUSINESS CORPORATION ACT. THIS INCLUDES ENSURING THAT YOUR NAME DOESN'T INCLUDE RESTRICTED WORDS AND ADHERES TO THE STATE'S NAMING GUIDELINES.

# TYPES OF BUSINESS NAMES
