UNDERSTANDING THE BASICS OF BUSINESS REGISTRATION

CHOOSING THE RIGHT BUSINESS STRUCTURE

2. PARTNERSHIP

A PARTNERSHIP INVOLVES TWO OR MORE INDIVIDUALS WHO SHARE OWNERSHIP OF A BUSINESS. PARTNERSHIPS CAN BE GENERAL OR LIMITED, WITH GENERAL PARTNERS MANAGING THE BUSINESS AND BEING PERSONALLY LIABLE, WHILE LIMITED PARTNERS HAVE RESTRICTED LIABILITY.

3. LIMITED LIABILITY COMPANY (LLC)

AN LLC COMBINES THE BENEFITS OF A CORPORATION AND A SOLE PROPRIETORSHIP. IT PROVIDES PERSONAL LIABILITY PROTECTION FOR OWNERS WHILE ALLOWING FOR FLEXIBLE TAX TREATMENT. THIS STRUCTURE IS INCREASINGLY POPULAR AMONG SMALL BUSINESS OWNERS.

4. CORPORATION

A CORPORATION IS A MORE COMPLEX STRUCTURE THAT IS LEGALLY DISTINCT FROM ITS OWNERS. CORPORATIONS CAN RAISE CAPITAL BY ISSUING STOCK AND PROVIDE LIMITED LIABILITY PROTECTION. HOWEVER, THEY FACE MORE REGULATORY REQUIREMENTS AND DOUBLE TAXATION ON PROFITS.

CHOOSING THE CORRECT STRUCTURE IS VITAL, AS IT WILL IMPACT YOUR BUSINESS OPERATIONS, TAXES, AND COMPLIANCE OBLIGATIONS. IT IS ADVISABLE TO CONSULT WITH A LEGAL EXPERT OR ACCOUNTANT TO DETERMINE THE BEST FIT FOR YOUR BUSINESS GOALS.

STEPS TO REGISTER YOUR SMALL BUSINESS
