Still retaining an adolescent vision of herself as a partial invalid, Tam has had a habit of living and reliving the minor traumas of her past-but Nat gives her the chance to be someone different, yet still the same: Tam is, for all intents and purposes, a ghost, but Nat's version of her ghostliness ascribes to it the kind of heroic mystery and romance that Tam has always assumed her brother to have but which Nat now gives her for herself. Meanwhile, in the real world, to add to the drama, Tam has "rescued" a baby who has been taken from his teenage mother, by sneaking it out from the small seaside hospital, and hiding both mother and child with herself at the privately owned lighthouse where her ancestors once lived. Tam's romantic quest to experience her ancestors' tragedies and heartbreak takes the particular form of a fascination with Mary Catherine, an ancestor who died at the age of 33 and onto whom Tam projects all her own anxieties but this alternate life is invaded by the reappearance of her brother. And Tam, in a commanding re-entry into the water, chooses to close the book on her life of self-imposed susceptibility.
