INCLUDE KEY PIECES OF INFORMATION ON YOUR BUSINESS CARD, SUCH AS:

- YOUR NAME AND TITLE
- BUSINESS NAME
- CONTACT NUMBER
- EMAIL ADDRESS
- WEBSITE URL
- PHYSICAL ADDRESS (IF APPLICABLE)

ENSURE THAT THE TEXT IS LEGIBLE AND THAT THE MOST CRITICAL INFORMATION STANDS OUT. AVOID CLUTTERING THE CARD WITH EXCESSIVE DETAILS, AS SIMPLICITY OFTEN LEADS TO A MORE PROFESSIONAL APPEARANCE.

VISUAL ELEMENTS

INCORPORATE VISUAL ELEMENTS THAT ENHANCE THE CARD'S APPEAL. THIS MIGHT INCLUDE:

- HIGH-QUALITY IMAGES OR GRAPHICS
- UNIQUE SHAPES OR CUTS
- TEXTURED FINISHES
- USE OF COLOR TO DRAW ATTENTION

VISUAL ELEMENTS SHOULD COMPLEMENT YOUR BRANDING AND NOT OVERWHELM THE ESSENTIAL INFORMATION. A WELL-BALANCED DESIGN CAPTURES ATTENTION WITHOUT SACRIFICING PROFESSIONALISM.

EFFECTIVE DISTRIBUTION STRATEGIES
