## WHAT IS A BUSINESS LICENCE?

A BUSINESS LICENCE IS AN OFFICIAL PERMIT ISSUED BY A GOVERNMENTAL AUTHORITY THAT ALLOWS INDIVIDUALS OR ENTITIES TO CONDUCT BUSINESS ACTIVITIES LEGALLY WITHIN A SPECIFIC AREA. ### Q: IS A BUSINESS LICENCE THE SAME AS A TAX ID NUMBER?

A: NO, A BUSINESS LICENCE IS AN AUTHORIZATION TO OPERATE, WHILE A TAX ID NUMBER (EIN) IS USED FOR TAX PURPOSES

AND TO IDENTIFY A BUSINESS ENTITY TO THE IRS.

### Q: WILL I NEED TO RENEW MY BUSINESS LICENCE?

A: YES, MOST BUSINESS LICENCES REQUIRE PERIODIC RENEWAL, WHICH MAY INVOLVE SUBMITTING UPDATED INFORMATION AND PAYING RENEWAL FEES.

### Q: WHAT SHOULD I DO IF MY BUSINESS LICENCE APPLICATION IS DENIED?

A: IF YOUR APPLICATION IS DENIED, YOU SHOULD REVIEW THE REASONS FOR DENIAL, ADDRESS ANY ISSUES, AND CONSIDER REAPPLYING OR APPEALING THE DECISION ACCORDING TO THE LOCAL AUTHORITY'S PROCEDURES.
