OVERVIEW OF THE VERIZON SMALL BUSINESS GRANT 2023

THE VERIZON SMALL BUSINESS GRANT 2023 IS DESIGNED TO SUPPORT SMALL BUSINESS OWNERS BY PROVIDING FINANCIAL ASSISTANCE AIMED AT FOSTERING GROWTH AND INNOVATION. THIS INITIATIVE REFLECTS VERIZON'S COMMITMENT TO EMPOWERING ENTREPRENEURS WHO CONTRIBUTE TO THEIR COMMUNITIES AND THE ECONOMY. IN 2023, THE PROGRAM OFFERS A TOTAL OF \$1 MILLION IN GRANTS, WITH INDIVIDUAL AWARDS REACHING UP TO \$10,000. THESE FUNDS ARE INTENDED TO ASSIST WITH VARIOUS BUSINESS-RELATED EXPENSES, SUCH AS OPERATIONAL COSTS, MARKETING EFFORTS, AND TECHNOLOGY UPGRADES.

THE GRANT PROGRAM NOT ONLY PROVIDES FINANCIAL SUPPORT BUT ALSO OFFERS ACCESS TO RESOURCES, MENTORSHIP, AND NETWORKING OPPORTUNITIES. THIS HOLISTIC APPROACH HELPS SMALL BUSINESSES BUILD RESILIENCE AND ADAPT TO CHANGING MARKET CONDITIONS. BY PRIORITIZING FUNDING FOR DIVERSE AND UNDERREPRESENTED ENTREPRENEURS, VERIZON AIMS TO CREATE A MORE INCLUSIVE BUSINESS LANDSCAPE.

ELIGIBILITY CRITERIA FOR APPLICANTS

TO QUALIFY FOR THE VERIZON SMALL BUSINESS GRANT 2023, APPLICANTS MUST MEET SPECIFIC CRITERIA. UNDERSTANDING THESE REQUIREMENTS IS CRUCIAL FOR SMALL BUSINESS OWNERS AIMING TO SECURE FUNDING. BELOW ARE THE PRIMARY ELIGIBILITY CRITERIA:

- **BUSINESS SIZE:** APPLICANTS MUST OPERATE A SMALL BUSINESS WITH 1-100 EMPLOYEES.

- **LOCATION:** THE BUSINESS MUST BE LOCATED IN THE UNITED STATES.
- **BUSINESS TYPE:** ELIGIBLE BUSINESSES INCLUDE THOSE IN VARIOUS SECTORS, SUCH AS RETAIL, SERVICES, AND TECHNOLOGY.
- **TIME IN BUSINESS:** THE BUSINESS MUST HAVE BEEN OPERATIONAL FOR AT LEAST SIX MONTHS PRIOR TO THE APPLICATION.
- **FINANCIAL NEED:** APPLICANTS SHOULD DEMONSTRATE A NEED FOR FINANCIAL ASSISTANCE, PARTICULARLY FOR RECOVERY OR GROWTH INITIATIVES.

ADDITIONALLY, VERIZON ENCOURAGES APPLICATIONS FROM DIVERSE BUSINESS OWNERS, INCLUDING WOMEN, PEOPLE OF COLOR, AND THOSE IN UNDERSERVED COMMUNITIES. THIS FOCUS AIMS TO PROMOTE EQUITY AND PROVIDE OPPORTUNITIES FOR THOSE WHO MAY FACE SYSTEMIC BARRIERS IN ACCESSING FUNDING.
