IT SERVES AS A CENTRAL REPOSITORY FOR INFORMATION ABOUT ALL BUSINESS ENTITIES REGISTERED TO OPERATE IN THE STATE. THIS DATABASE INCLUDES DETAILS SUCH AS THE BUSINESS NAME, TYPE, STATUS, REGISTERED AGENT, AND FILING HISTORY. THE PRIMARY PURPOSE OF THE REGISTER IS TO PROVIDE A TRANSPARENT AND ACCESSIBLE SOURCE OF BUSINESS INFORMATION FOR BOTH THE PUBLIC AND PRIVATE SECTORS.

- **LIMITED LIABILITY COMPANIES (LLCs):** A POPULAR CHOICE FOR SMALL BUSINESSES, OFFERING LIABILITY PROTECTION TO OWNERS. LLCs MUST FILE ARTICLES OF ORGANIZATION WITH THE DFI.
- **CORPORATIONS:** MORE COMPLEX ENTITIES THAT PROVIDE LIABILITY PROTECTION TO SHAREHOLDERS. CORPORATIONS MUST FILE ARTICLES OF INCORPORATION AND ADHERE TO ONGOING REGULATORY REQUIREMENTS.
- **NONPROFIT ORGANIZATIONS:** ENTITIES FORMED FOR CHARITABLE PURPOSES. NONPROFITS MUST REGISTER WITH THE STATE AND MAY ALSO SEEK FEDERAL TAX-EXEMPT STATUS.

EACH ENTITY TYPE HAS ITS OWN ADVANTAGES AND DISADVANTAGES, MAKING IT ESSENTIAL FOR BUSINESS OWNERS TO EVALUATE THEIR OPTIONS CAREFULLY BEFORE REGISTERING.

THE REGISTRATION PROCESS
