A HEAVY HIGHWAY VEHICLE SUBJECT TO FORM 2290 FILING INCLUDES TRUCKS, TRUCK TRACTORS, AND BUSES WITH A TAXABLE GROSS WEIGHT OF 55,000 POUNDS OR MORE. THE HVUT IS DESIGNED TO OFFSET THE WEAR AND TEAR HEAVY VEHICLES IMPOSE ON PUBLIC HIGHWAYS. SINCE HEAVIER VEHICLES CAUSE MORE DAMAGE TO ROAD SURFACES, THE TAX COLLECTED HELPS FUND HIGHWAY REPAIRS AND IMPROVEMENTS TO ENSURE SAFETY AND LONGEVITY OF ROAD INFRASTRUCTURE.
