THIS CONCEPT EMERGED IN THE EARLY 20TH CENTURY FROM ROBERT BRIFFAULT'S ANTHROPOLOGICAL WORK, EMPHASIZING FEMALE AGENCY IN MATING AND SOCIAL STRUCTURES. THE LAW HAS BEEN INFLUENTIAL IN FRAMING DEBATES ABOUT SEXUAL SELECTION, PARENTAL INVESTMENT, AND MATING STRATEGIES.

ORIGINS AND DEFINITION

ROBERT BRIFFAULT INTRODUCED THIS PRINCIPLE IN HIS BOOK "THE MOTHERS" (1927), WHERE HE ARGUED THAT THE FEMALE'S CHOICE IS THE ULTIMATE DETERMINANT IN THE FORMATION AND MAINTENANCE OF SOCIAL BONDS. APPLICATIONS IN EVOLUTIONARY BIOLOGY

In evolutionary biology, briffault's law is often cited to explain female mate choice and resource allocation. It has been used to interpret behaviors across species where females are selective in mating, and males compete by offering valuable resources.
