Another filched food from the officer's dining room (with the acquiescence of the COs) and sells it on the tier. A third played the stock market. The fourth was a racist and studying for a GED. Inmates get killed, OD, and commit suicide, but the greatest harm is caused by the inhumane environment. The book shows that violence and brutality can take subtle forms.
