Such works have also positioned that search outside the character's family or community and have usually emphasized its futility. With the growing shift toward multiculturalism in fiction, however, folk traditions have come to play an increasingly crucial role in characters' journeys to self-awareness as well as in the success of those journeys. Thoroughly researched and cogently argued, this book makes a significant contribution to the study of both folklore and literature as it explores the relationship between knowing one's cultural heritage and achieving a sense of self that is whole instead of fragmented, connected instead of drifting.
