THIS ENDORSEMENT IS MANDATORY FOR DRIVERS INTENDING TO OPERATE BUSES, MOTORCOACHES, VANS, OR ANY OTHER COMMERCIAL VEHICLE THAT TRANSPORTS PEOPLE. IT ENSURES THAT DRIVERS HAVE A THOROUGH UNDERSTANDING OF PASSENGER SAFETY, VEHICLE INSPECTION, AND EMERGENCY PROCEDURES SPECIFIC TO PASSENGER TRANSPORT.

PURPOSE OF THE PASSENGER ENDORSEMENT

THE PRIMARY GOAL OF THE PASSENGER ENDORSEMENT IS TO PROMOTE SAFETY ON THE ROAD BY REQUIRING DRIVERS TO DEMONSTRATE KNOWLEDGE OF PASSENGER-SPECIFIC RESPONSIBILITIES. TYPES OF VEHICLES COVERED

THE PASSENGER ENDORSEMENT APPLIES TO A RANGE OF COMMERCIAL VEHICLES, INCLUDING:

- TRANSIT BUSES
- SCHOOL BUSES (IN SOME STATES A SEPARATE ENDORSEMENT MAY APPLY)
- CHARTER BUSES AND MOTORCOACHES
- SHUTTLE VANS AND PASSENGER VANS

- OTHER COMMERCIAL VEHICLES DESIGNED TO CARRY 16 OR MORE PASSENGERS INCLUDING THE DRIVER

ELIGIBILITY AND APPLICATION PROCESS

BEFORE TAKING THE CDL PASSENGER ENDORSEMENT TEST, APPLICANTS MUST MEET SPECIFIC ELIGIBILITY REQUIREMENTS. THESE REQUIREMENTS ENSURE THAT THE DRIVER IS QUALIFIED AND PREPARED TO HANDLE THE RESPONSIBILITIES ASSOCIATED WITH TRANSPORTING PASSENGERS.

BASIC CDL REQUIREMENTS

TO APPLY FOR THE PASSENGER ENDORSEMENT, AN INDIVIDUAL MUST FIRST POSSESS A VALID COMMERCIAL DRIVER'S LICENSE (CDL). THE BASIC REQUIREMENTS FOR OBTAINING A CDL ARE:

- MINIMUM AGE OF 18 YEARS FOR INTRASTATE DRIVING; 21 YEARS FOR INTERSTATE DRIVING
- PASSING A MEDICAL EXAMINATION AND HOLDING A MEDICAL EXAMINER'S CERTIFICATE
- PASSING THE CDL GENERAL KNOWLEDGE TEST
- PROVIDING PROOF OF IDENTITY, RESIDENCY, AND LAWFUL PRESENCE IN THE U.S.

ADDITIONAL ENDORSEMENT APPLICATION

AFTER MEETING THE BASIC CDL CRITERIA, THE APPLICANT MUST APPLY FOR THE PASSENGER ENDORSEMENT THROUGH THEIR STATE'S DEPARTMENT OF MOTOR VEHICLES (DMV) OR EQUIVALENT AGENCY. THIS USUALLY INVOLVES:

1. SUBMITTING AN ENDORSEMENT APPLICATION
2. PAYING ANY APPLICABLE FEES
3. SCHEDULING AND PASSING THE PASSENGER ENDORSEMENT KNOWLEDGE TEST
4. COMPLETING ANY REQUIRED SKILLS OR ROAD TESTS, IF APPLICABLE

CONTENT AND FORMAT OF THE CDL PASSENGER ENDORSEMENT TEST

FEDERAL AND STATE REGULATIONS

THE FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION (FMCSA) SETS NATIONWIDE STANDARDS FOR PASSENGER TRANSPORT, WHICH STATES ENFORCE ALONGSIDE THEIR OWN REGULATIONS. THESE INCLUDE:

- HOURS OF SERVICE LIMITS FOR PASSENGER VEHICLE DRIVERS
- MANDATORY VEHICLE INSPECTIONS AND MAINTENANCE
- REQUIRED SAFETY EQUIPMENT AND EMERGENCY EXITS ON PASSENGER VEHICLES
- PROPER LICENSING AND ENDORSEMENT REQUIREMENTS
- PASSENGER SAFETY PROTOCOLS, INCLUDING SEAT BELT USE

SAFETY AND EMERGENCY PROCEDURES

DRIVERS MUST BE TRAINED IN HANDLING EMERGENCIES SUCH AS VEHICLE BREAKDOWNS, FIRES, OR PASSENGER MEDICAL INCIDENTS. THE ENDORSEMENT TEST OFTEN EVALUATES KNOWLEDGE OF EVACUATION PROCEDURES, EMERGENCY COMMUNICATION, AND FIRST AID BASICS.
