## HISTORICAL BACKGROUND OF FAR RIGHT POLITICS IN THE US

THE FAR RIGHT POLITICS IN THE US HAS DEEP HISTORICAL ROOTS DATING BACK TO THE EARLY 20TH CENTURY, OFTEN EMERGING IN RESPONSE TO SOCIAL, ECONOMIC, AND POLITICAL CHANGES. MOVEMENTS SUCH AS THE KU KLUX KLAN IN THE POST-RECONSTRUCTION ERA EXEMPLIFY EARLY FAR RIGHT ACTIVISM CENTERED ON WHITE SUPREMACY AND RACIAL SEGREGATION. THROUGHOUT THE 1920S AND 1930S, FAR RIGHT GROUPS GAINED TRACTION BY OPPOSING IMMIGRATION AND PROMOTING NATIONALIST AGENDAS. THE COLD WAR ERA SAW FAR RIGHT FACTIONS EMPHASIZING ANTI-COMMUNISM AND CONSERVATIVE SOCIAL VALUES. THESE HISTORICAL DEVELOPMENTS HAVE SHAPED THE MODERN FAR RIGHT, WHICH CONTINUES TO EVOLVE IN RESPONSE TO CONTEMPORARY ISSUES.

## EARLY 20TH CENTURY MOVEMENTS

DURING THE EARLY 1900S, FAR RIGHT POLITICS IN THE US WERE CHARACTERIZED BY RACIAL AND ETHNIC EXCLUSION, WITH GROUPS ADVOCATING FOR WHITE ANGLO-SAXON PROTESTANT DOMINANCE. THE RESURGENCE OF THE KU KLUX KLAN IN THE 1920S, FOR EXAMPLE, TARGETED AFRICAN AMERICANS, CATHOLICS, JEWS, AND IMMIGRANTS, PROMOTING A NATIVIST IDEOLOGY. THIS PERIOD ALSO WITNESSED THE RISE OF FASCIST SYMPATHIZERS AND ISOLATIONIST GROUPS OPPOSING FOREIGN INVOLVEMENT.

## POST-WAR DEVELOPMENTS

FOLLOWING WORLD WAR II, FAR RIGHT POLITICS SHIFTED FOCUS TO ANTI-COMMUNISM, WITH ORGANIZATIONS OPPOSING PERCEIVED THREATS FROM THE SOVIET UNION AND LEFTIST IDEOLOGIES. THE CIVIL RIGHTS MOVEMENT OF THE 1950S AND 1960S SPARKED BACKLASH FROM FAR RIGHT GROUPS RESISTING RACIAL INTEGRATION AND SOCIAL CHANGE. THESE DYNAMICS LAID THE GROUNDWORK FOR LATER FAR RIGHT ACTIVISM CENTERED ON CULTURAL CONSERVATISM AND OPPOSITION TO FEDERAL AUTHORITY.

# CORE IDEOLOGIES AND BELIEFS

FAR RIGHT POLITICS IN THE US ENCOMPASSES A VARIETY OF IDEOLOGIES THAT OFTEN OVERLAP BUT SHARE COMMON THEMES SUCH AS NATIONALISM, AUTHORITARIANISM, AND TRADITIONALISM. THESE BELIEFS EMPHASIZE PRESERVING A PARTICULAR VISION OF AMERICAN IDENTITY AND SOCIAL ORDER, FREQUENTLY ACCOMPANIED BY SKEPTICISM OR HOSTILITY TOWARD IMMIGRATION, MULTICULTURALISM, AND PROGRESSIVE POLICIES.

## NATIONALISM AND IDENTITY

NATIONALISM PLAYS A CENTRAL ROLE IN FAR RIGHT IDEOLOGY, WITH AN EMPHASIS ON PROTECTING PERCEIVED AMERICAN HERITAGE AND CULTURAL HOMOGENEITY. THIS OFTEN INCLUDES ADVOCATING FOR STRICT IMMIGRATION CONTROLS AND OPPOSING GLOBALIZATION. THE CONCEPT OF NATIONAL IDENTITY IS FREQUENTLY TIED TO RACE, RELIGION, OR ETHNICITY, FOSTERING EXCLUSIONARY ATTITUDES.

## AUTHORITARIANISM AND ANTI-GOVERNMENT SENTIMENT

MANY FAR RIGHT FACTIONS DISPLAY AUTHORITARIAN TENDENCIES, FAVORING STRONG LEADERSHIP AND SOCIAL ORDER. SIMULTANEOUSLY, THERE IS OFTEN DEEP DISTRUST OF FEDERAL GOVERNMENT INSTITUTIONS, WHICH ARE SEEN AS OVERREACHING OR CORRUPT. THIS PARADOX MANIFESTS IN CALLS FOR LIMITED GOVERNMENT ALONGSIDE SUPPORT FOR LAW AND ORDER POLICIES.

## SOCIAL CONSERVATISM

TRADITIONAL SOCIAL VALUES ARE A HALLMARK OF FAR RIGHT POLITICS, INCLUDING OPPOSITION TO LGBTQ+ RIGHTS, ABORTION, AND SECULARISM. THIS SOCIAL CONSERVATISM IS INTERTWINED WITH RELIGIOUS BELIEFS AND A DESIRE TO MAINTAIN ESTABLISHED SOCIAL HIERARCHIES.

# KEY GROUPS AND MOVEMENTS

THE FAR RIGHT POLITICAL LANDSCAPE IN THE US INCLUDES A DIVERSE ARRAY OF ORGANIZATIONS AND MOVEMENTS, EACH WITH DISTINCT GOALS BUT OFTEN UNITED BY SHARED IDEOLOGICAL THEMES. THESE GROUPS RANGE FROM POLITICALLY ACTIVE PARTIES TO LOOSELY ORGANIZED ONLINE COMMUNITIES.

# FREQUENTLY ASKED QUESTIONS

## WHAT DEFINES FAR RIGHT POLITICS IN THE US?

FAR RIGHT POLITICS IN THE US ARE CHARACTERIZED BY EXTREME CONSERVATIVE VIEWS, NATIONALISM, ANTI-IMMIGRATION STANCES, AND OFTEN A REJECTION OF MULTICULTURALISM AND LIBERAL DEMOCRATIC PRINCIPLES.

## HOW HAS FAR RIGHT POLITICS IN THE US EVOLVED RECENTLY?

FAR RIGHT POLITICS IN THE US HAVE GAINED VISIBILITY THROUGH INCREASED SOCIAL MEDIA PRESENCE, PARTICIPATION IN PROTESTS, AND INFLUENCE ON CERTAIN POLITICAL CANDIDATES, OFTEN MARKED BY A FOCUS ON POPULISM AND ANTI-

ESTABLISHMENT RHETORIC.

## WHAT ARE SOME KEY GROUPS ASSOCIATED WITH FAR RIGHT POLITICS IN THE US?

KEY GROUPS INCLUDE WHITE NATIONALIST ORGANIZATIONS, MILITIAS, AND SOME FACTIONS WITHIN THE BROADER CONSERVATIVE MOVEMENT THAT PROMOTE FAR RIGHT IDEOLOGIES.

## HOW DOES FAR RIGHT POLITICS IMPACT US ELECTIONS?

FAR RIGHT POLITICS CAN INFLUENCE ELECTIONS BY MOBILIZING A BASE AROUND ISSUES LIKE IMMIGRATION AND NATIONAL IDENTITY, SOMETIMES AFFECTING CANDIDATE PLATFORMS AND VOTER TURNOUT.

## WHAT ROLE DOES SOCIAL MEDIA PLAY IN FAR RIGHT POLITICS IN THE US?

SOCIAL MEDIA PLATFORMS ARE USED BY FAR RIGHT GROUPS TO SPREAD THEIR MESSAGES, RECRUIT MEMBERS, AND ORGANIZE EVENTS, OFTEN EXPLOITING ALGORITHMIC AMPLIFICATION TO REACH WIDER AUDIENCES.

## ARE FAR RIGHT POLITICAL VIEWS REPRESENTED IN MAINSTREAM US POLITICS?

WHILE MAINSTREAM POLITICS GENERALLY AVOID EXTREMIST POSITIONS, SOME FAR RIGHT IDEAS HAVE BEEN MAINSTREAMED OR ECHOED BY CERTAIN POLITICIANS, PARTICULARLY ON ISSUES LIKE IMMIGRATION AND LAW ENFORCEMENT.

## WHAT ARE THE CONCERNS RELATED TO FAR RIGHT POLITICS IN THE US?

CONCERNS INCLUDE THE PROMOTION OF HATE SPEECH, POTENTIAL FOR POLITICAL VIOLENCE, EROSION OF DEMOCRATIC NORMS, AND INCREASED SOCIAL POLARIZATION.

## HOW DOES FAR RIGHT POLITICS IN THE US DIFFER FROM FAR RIGHT MOVEMENTS IN EUROPE?

WHILE SHARING THEMES LIKE NATIONALISM AND ANTI-IMMIGRATION, US FAR RIGHT POLITICS ARE OFTEN MORE INFLUENCED BY GUN RIGHTS ISSUES AND HAVE A UNIQUE HISTORICAL CONTEXT RELATED TO RACE RELATIONS.

## WHAT MEASURES ARE BEING TAKEN TO COUNTER FAR RIGHT EXTREMISM IN THE US?

EFFORTS INCLUDE LAW ENFORCEMENT MONITORING, DE-RADICALIZATION PROGRAMS, SOCIAL MEDIA REGULATION, AND COMMUNITY OUTREACH INITIATIVES TO PREVENT RADICALIZATION.

## HOW DO FAR RIGHT POLITICS AFFECT MINORITY COMMUNITIES IN THE US?

FAR RIGHT POLITICS CAN LEAD TO INCREASED DISCRIMINATION, HATE CRIMES, AND SOCIAL MARGINALIZATION OF MINORITY COMMUNITIES, IMPACTING THEIR SAFETY AND RIGHTS.

The book will illustrate processes by which racialized subjects are produced and violence justified. In order to do so, the book concentrates on popular culture as sources of how the far-right constitutes their identities and goals. It first develops a methodological plan to study popular culture artifacts that is drawn from scholarship on race and discourse analysis in International Relations (IR). It then analyzes far-right use of key popular culture artifacts, such as magazines, memes, and manifestos, to note how extremist identities and interests are produced, publicly communicated, and mainstreamed. This will contribute to Security Studies and IR's understanding of far-right extremism, especially how they utilize similar narrative strategies as used in mainstream contexts to justify their calls for violence.
