OVERVIEW OF ILLINOIS DOT PHYSICAL CARD REQUIREMENTS

THE ILLINOIS DOT PHYSICAL CARD IS A CERTIFICATION ISSUED TO COMMERCIAL DRIVERS WHO HAVE SUCCESSFULLY PASSED A DEPARTMENT OF TRANSPORTATION PHYSICAL EXAMINATION. THIS CARD VERIFIES THAT THE DRIVER MEETS ALL MEDICAL STANDARDS NECESSARY TO OPERATE COMMERCIAL MOTOR VEHICLES SAFELY. COMPLIANCE WITH THESE REQUIREMENTS IS MANDATED BY BOTH ILLINOIS STATE LAW AND FEDERAL REGULATIONS UNDER THE FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION (FMCSA).

DRIVERS MUST HOLD A VALID CDL (COMMERCIAL DRIVER'S LICENSE) AND UNDERGO A MEDICAL EXAMINATION CONDUCTED BY A CERTIFIED MEDICAL EXAMINER LISTED ON THE NATIONAL REGISTRY OF CERTIFIED MEDICAL EXAMINERS. THE ILLINOIS DOT PHYSICAL CARD SERVES AS PROOF THAT THE DRIVER HAS MET ALL HEALTH CRITERIA, INCLUDING VISION, HEARING, CARDIOVASCULAR, AND NEUROLOGICAL STANDARDS, AMONG OTHERS.

FAILURE TO OBTAIN OR MAINTAIN A VALID DOT PHYSICAL CARD CAN RESULT IN SUSPENSION OR REVOCATION OF DRIVING PRIVILEGES, FINES, AND OTHER LEGAL CONSEQUENCES. THEREFORE, UNDERSTANDING AND ADHERING TO THE ILLINOIS DOT PHYSICAL CARD REQUIREMENTS IS IMPERATIVE FOR ALL COMMERCIAL DRIVERS.

ELIGIBILITY AND MEDICAL EXAMINATION PROCESS

TO BE ELIGIBLE FOR THE ILLINOIS DOT PHYSICAL CARD, DRIVERS MUST MEET SPECIFIC HEALTH AND SAFETY STANDARDS ESTABLISHED BY THE FMCSA AND ADOPTED BY ILLINOIS. THE MEDICAL EXAMINATION IS A CRITICAL STEP IN THE PROCESS, ENSURING THAT DRIVERS DO NOT POSE A RISK TO PUBLIC SAFETY.

WHO MUST OBTAIN A DOT PHYSICAL CARD?

ANY INDIVIDUAL OPERATING A COMMERCIAL MOTOR VEHICLE REQUIRING A CDL MUST OBTAIN A DOT PHYSICAL CARD. THIS INCLUDES DRIVERS OF TRUCKS, BUSES, HAZARDOUS MATERIALS CARRIERS, AND OTHER COMMERCIAL VEHICLES AS DEFINED BY FEDERAL AND STATE REGULATIONS. EVEN PART-TIME DRIVERS OR THOSE OPERATING IN INTERSTATE COMMERCE MUST COMPLY

WITH THESE REQUIREMENTS.

MEDICAL EXAMINATION COMPONENTS

THE MEDICAL EXAMINATION CONDUCTED FOR THE ILLINOIS DOT PHYSICAL CARD INCLUDES A THOROUGH EVALUATION OF THE DRIVER'S HEALTH STATUS. KEY COMPONENTS OF THE EXAMINATION INCLUDE:

- **VISION TEST:** DRIVERS MUST HAVE AT LEAST 20/40 VISION IN EACH EYE WITH OR WITHOUT CORRECTIVE LENSES.
- **HEARING TEST:** DRIVERS MUST BE ABLE TO PERCEIVE A FORCED WHISPER AT A DISTANCE OF AT LEAST 5 FEET OR MEET AUDIOMETRIC STANDARDS.
- **BLOOD PRESSURE AND CARDIOVASCULAR ASSESSMENT:** BLOOD PRESSURE MUST BE WITHIN ACCEPTABLE LIMITS, AND ANY CARDIOVASCULAR CONDITIONS MUST BE EVALUATED.
- **NEUROLOGICAL EVALUATION:** ASSESSMENT FOR DISORDERS SUCH AS EPILEPSY OR ANY CONDITION THAT COULD CAUSE SUDDEN LOSS OF CONSCIOUSNESS.
- **URINALYSIS:** SCREENING FOR DIABETES OR KIDNEY DISEASE THROUGH URINE TESTING.
- **GENERAL PHYSICAL HEALTH:** OVERALL ASSESSMENT OF PHYSICAL FITNESS, INCLUDING MUSCULOSKELETAL HEALTH.

THE MEDICAL EXAMINER USES THE FMCSA MEDICAL EXAMINATION REPORT FORM (MCSA-5875) TO DOCUMENT FINDINGS. BASED ON THE RESULTS, THE EXAMINER WILL DETERMINE IF THE DRIVER QUALIFIES FOR THE DOT PHYSICAL CARD.

DOCUMENTATION AND APPLICATION PROCEDURES

PROPER DOCUMENTATION IS ESSENTIAL FOR APPLYING FOR OR RENEWING THE ILLINOIS DOT PHYSICAL CARD. DRIVERS MUST PREPARE SPECIFIC PAPERWORK BEFORE UNDERGOING THE MEDICAL EXAMINATION AND SUBMITTING APPLICATIONS.

REQUIRED DOCUMENTS FOR THE MEDICAL EXAMINATION

DRIVERS SHOULD BRING THE FOLLOWING TO THEIR APPOINTMENT WITH A CERTIFIED MEDICAL EXAMINER:

- VALID GOVERNMENT-ISSUED PHOTO IDENTIFICATION (E.G., DRIVER'S LICENSE OR STATE ID)
- CURRENT CDL OR PROOF OF CDL APPLICATION
- LIST OF CURRENT MEDICATIONS AND MEDICAL HISTORY
- PREVIOUS DOT PHYSICAL CARD (IF APPLICABLE)
- COMPLETED MEDICAL HISTORY QUESTIONNAIRE PROVIDED BY THE MEDICAL EXAMINER

APPLICATION AND ISSUANCE OF THE DOT PHYSICAL CARD

ONCE THE MEDICAL EXAMINATION IS COMPLETED AND THE DRIVER IS CERTIFIED FIT TO OPERATE, THE MEDICAL EXAMINER ISSUES A MEDICAL CERTIFICATE, COMMONLY KNOWN AS THE DOT PHYSICAL CARD. THIS CARD TYPICALLY INDICATES THE VALIDITY PERIOD, USUALLY UP TO 24 MONTHS, DEPENDING ON THE DRIVER'S MEDICAL CONDITION AND EXAMINER'S DISCRETION.

THE DRIVER MUST KEEP THE DOT PHYSICAL CARD READILY AVAILABLE WHILE OPERATING A COMMERCIAL VEHICLE, AS LAW ENFORCEMENT OFFICERS MAY REQUEST TO SEE IT DURING INSPECTIONS OR ROADSIDE STOPS.

RENEWAL AND VALIDITY OF THE DOT PHYSICAL CARD

MAINTAINING AN UP-TO-DATE ILLINOIS DOT PHYSICAL CARD IS MANDATORY FOR CONTINUOUS OPERATION OF COMMERCIAL MOTOR VEHICLES. UNDERSTANDING THE RENEWAL PROCESS AND THE CARD'S VALIDITY PERIOD IS CRUCIAL FOR COMPLIANCE AND AVOIDING INTERRUPTIONS IN DRIVING PRIVILEGES.

VALIDITY PERIOD OF THE DOT PHYSICAL CARD

THE STANDARD VALIDITY PERIOD FOR THE ILLINOIS DOT PHYSICAL CARD IS UP TO 24 MONTHS. HOWEVER, SHORTER DURATIONS MAY BE ASSIGNED IF THE DRIVER HAS CERTAIN MEDICAL CONDITIONS THAT REQUIRE MORE FREQUENT MONITORING. IT IS IMPORTANT TO NOTE THE EXPIRATION DATE CLEARLY TO ENSURE TIMELY RENEWAL.

RENEWAL PROCESS

TO RENEW THE DOT PHYSICAL CARD, DRIVERS MUST UNDERGO ANOTHER MEDICAL EXAMINATION BY A CERTIFIED MEDICAL EXAMINER BEFORE THE CURRENT CARD EXPIRES. THE RENEWAL PROCESS INCLUDES:

1. SCHEDULING AN APPOINTMENT WITH A CERTIFIED MEDICAL EXAMINER.
2. COMPLETING THE REQUIRED MEDICAL EXAMINATION AND TESTS.
3. SUBMITTING UPDATED MEDICAL HISTORY AND DOCUMENTATION AS NECESSARY.
4. OBTAINING A NEW MEDICAL CERTIFICATE INDICATING CONTINUED FITNESS TO DRIVE.
5. UPDATING THE MEDICAL CERTIFICATION INFORMATION WITH THE ILLINOIS SECRETARY OF STATE IF REQUIRED.

RENEWING THE DOT PHYSICAL CARD IN A TIMELY MANNER PREVENTS LAPSES IN COMPLIANCE AND HELPS AVOID PENALTIES OR LOSS OF CDL DRIVING PRIVILEGES.

- KEEP A DETAILED RECORD OF MEDICAL HISTORY AND MEDICATIONS TO PROVIDE ACCURATE INFORMATION DURING YOUR EXAM.
- USE ONLY CERTIFIED MEDICAL EXAMINERS LISTED ON THE NATIONAL REGISTRY TO ENSURE YOUR PHYSICAL IS VALID.

- CARRY YOUR DOT PHYSICAL CARD AT ALL TIMES WHEN OPERATING A COMMERCIAL VEHICLE.

FREQUENTLY ASKED QUESTIONS

Q: CAN I USE MY ILLINOIS DOT PHYSICAL CARD IN OTHER STATES?

A: YES, THE ILLINOIS DOT PHYSICAL CARD COMPLIES WITH FEDERAL STANDARDS AND IS RECOGNIZED NATIONWIDE.

Q: WHAT HAPPENS IF I FAIL THE DOT PHYSICAL EXAM?

A: IF A DRIVER FAILS THE EXAM DUE TO MEDICAL REASONS, THE MEDICAL EXAMINER MAY DISQUALIFY THE DRIVER FROM HOLDING A CDL UNTIL THE CONDITION IS TREATED OR MANAGED. THE DRIVER MAY ALSO RECEIVE A SHORTER-TERM CERTIFICATION WITH SPECIFIC RESTRICTIONS.

Q: HOW MUCH DOES A DOT PHYSICAL EXAM TYPICALLY COST IN ILLINOIS?

A: COSTS VARY BUT GENERALLY RANGE FROM \$75 TO \$150 DEPENDING ON THE PROVIDER. INSURANCE MAY NOT COVER THE EXAM SINCE IT IS A REQUIREMENT FOR COMMERCIAL DRIVING.

Q: ARE THERE EXEMPTIONS TO THE DOT PHYSICAL CARD REQUIREMENTS?

A: CERTAIN DRIVERS, SUCH AS THOSE OPERATING VEHICLES EXCLUSIVELY WITHIN CITY LIMITS OR FOR AGRICULTURAL PURPOSES, MAY BE EXEMPT, BUT IT IS IMPORTANT TO VERIFY SPECIFIC CONDITIONS WITH ILLINOIS REGULATIONS.

HOW OFTEN DO I NEED TO RENEW MY ILLINOIS DOT PHYSICAL CARD?

ILLINOIS DOT PHYSICAL CARDS TYPICALLY NEED TO BE RENEWED EVERY 24 MONTHS, BUT THIS CAN VARY IF THE MEDICAL EXAMINER SPECIFIES A SHORTER PERIOD BASED ON THE DRIVER'S HEALTH.

WHERE CAN I GET MY ILLINOIS DOT PHYSICAL CARD?

YOU CAN OBTAIN YOUR ILLINOIS DOT PHYSICAL CARD BY UNDERGOING A PHYSICAL EXAMINATION WITH A CERTIFIED MEDICAL EXAMINER LISTED ON THE FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION (FMCSA) NATIONAL REGISTRY.

WHAT DOCUMENTS ARE REQUIRED FOR THE ILLINOIS DOT PHYSICAL CARD?

YOU NEED TO BRING A VALID PHOTO ID, YOUR DRIVER'S LICENSE, AND ANY MEDICAL RECORDS RELEVANT TO YOUR HEALTH CONDITION TO THE DOT PHYSICAL EXAMINATION.

CAN I USE A DOT PHYSICAL CARD FROM ANOTHER STATE IN ILLINOIS?

YES, A DOT PHYSICAL CARD ISSUED BY A CERTIFIED MEDICAL EXAMINER IN ANY STATE IS VALID FOR COMMERCIAL DRIVING IN ILLINOIS, PROVIDED IT IS CURRENT AND MEETS FEDERAL STANDARDS.

WHAT HAPPENS IF I DRIVE WITHOUT A VALID ILLINOIS DOT PHYSICAL CARD?
