#### **ANCIENT RELIGIOUS CONTEXTS**

The Bible's origin is linked to various ancient religious traditions that influenced its content and themes. WITH THE SPREAD OF HELLENISTIC CULTURE AFTER THE CONQUESTS OF ALEXANDER THE GREAT, GREEK BECAME A DOMINANT LANGUAGE IN THE EASTERN MEDITERRANEAN. THE SEPTUAGINT, A GREEK TRANSLATION OF THE HEBREW SCRIPTURES, WAS PRODUCED BETWEEN THE 3RD AND 2ND CENTURIES BCE TO SERVE GREEK-SPEAKING JEWISH COMMUNITIES. THIS TRANSLATION PLAYED A CRUCIAL ROLE IN THE ORIGIN OF THE BIBLE AS IT INFLUENCED EARLY CHRISTIAN WRITINGS AND FACILITATED THE SPREAD OF BIBLICAL TEXTS BEYOND JEWISH AUDIENCES.

#### IMPORTANT MANUSCRIPTS

#### EARLY ISRAELITE WRITINGS

#### GOSPELS AND ACTS

The four canonical Gospels—Matthew, Mark, Luke, and John—Became central to New Testament formation through their detailed accounts of Jesus's ministry. The Acts of the Apostles, attributed to the same author as the Gospel of Luke, documents the spread of early Christianity after Jesus's ascension.

#### **EPISTLES AND REVELATION**

THE NEW TESTAMENT INCLUDES NUMEROUS LETTERS (EPISTLES) WRITTEN BY PAUL AND OTHER APOSTLES TO EARLY CHRISTIAN COMMUNITIES, ADDRESSING THEOLOGY, ETHICS, AND CHURCH ORGANIZATION. THE FINAL BOOK, REVELATION, OFFERS A PROPHETIC VISION OF THE END TIMES, CONTRIBUTING TO THE DIVERSE THEOLOGICAL PERSPECTIVES WITHIN THE NEW TESTAMENT.

#### CANONIZATION PROCESS

The New Testament canon took shape over the 2nd to 4th centuries CE, with early church leaders and councils affirming the 27 books recognized today. The process involved rejecting numerous other gospels and writings deemed heretical or non-apostolic. Key milestones included the Easter letter of Athanasius in 367 CE and the Councils of Hippo and Carthage in the late 4th century.

# TRANSMISSION AND TRANSLATION
