### Types of Outpatient Mental Health Programs

# INTENSIVE OUTPATIENT PROGRAMS (IOP)

Intensive outpatient programs provide a higher level of care compared to standard outpatient therapy. IOPs often require patients to attend multiple sessions per week, each lasting several hours. This format is ideal for individuals who need structured support but do not require inpatient hospitalization. IOPs often include a combination of individual therapy, group counseling, medication management, and life skills training.

# PARTIAL HOSPITALIZATION PROGRAMS (PHP)

PARTIAL HOSPITALIZATION PROGRAMS ARE A STEP BELOW FULL INPATIENT CARE BUT OFFER MORE COMPREHENSIVE TREATMENT THAN IOPS. PATIENTS TYPICALLY ATTEND THE PROGRAM DURING THE DAY AND RETURN HOME AT NIGHT. PHPS ARE DESIGNED FOR THOSE WHO NEED CLOSE MONITORING AND INTENSIVE THERAPY BUT ARE STABLE ENOUGH TO LIVE OUTSIDE A HOSPITAL SETTING. SERVICES OFTEN INCLUDE PSYCHIATRIC EVALUATION, MEDICATION MANAGEMENT, AND MULTIPLE THERAPEUTIC

#### SPECIALIZED OUTPATIENT PROGRAMS

Specialized outpatient programs target specific conditions or populations. Examples include substance abuse outpatient programs, programs for adolescents, trauma-focused outpatient therapy, and programs tailored for veterans or individuals with co-occurring disorders. These programs use tailored interventions to address unique challenges and optimize recovery outcomes.
