THE NATURE OF REALITY

THIS INQUIRY INTERSECTS WITH METAPHYSICS, EXPLORING CONCEPTS SUCH AS SUBSTANCE, CAUSALITY, AND BEING.

METAPHYSICAL REALISM VS. IDEALISM

THE PROBLEM OF UNIVERSALS

THE PROBLEM OF UNIVERSALS ADDRESSES WHETHER PROPERTIES LIKE REDNESS OR BEAUTY EXIST INDEPENDENTLY OF PARTICULAR OBJECTS OR ONLY AS CONCEPTS IN THE MIND. THIS MYSTERY CHALLENGES THE UNDERSTANDING OF HOW GENERAL TERMS RELATE TO INDIVIDUAL INSTANCES AND THE ONTOLOGICAL STATUS OF ABSTRACT ENTITIES.

ONTOLOGY AND THE QUESTION OF BEING

ONTOLOGY IS THE BRANCH OF PHILOSOPHY CONCERNED WITH THE STUDY OF BEING AND EXISTENCE. DUALISM VS. PHYSICALISM

DUALISM POSITS THAT MIND AND BODY ARE DISTINCT SUBSTANCES, WITH MENTAL PHENOMENA IRREDUCIBLE TO PHYSICAL PROCESSES. IN CONTRAST, PHYSICALISM HOLDS THAT EVERYTHING ABOUT THE MIND CAN BE EXPLAINED IN TERMS OF PHYSICAL STATES AND FUNCTIONS. PHENOMENAL CONSCIOUSNESS AND SELF-AWARENESS

PHENOMENAL CONSCIOUSNESS REFERS TO THE EXPERIENTIAL QUALITIES OF AWARENESS, WHILE SELF-AWARENESS INVOLVES THE CAPACITY TO RECOGNIZE ONESELF AS DISTINCT. PHILOSOPHICAL MYSTERIES ARISE IN UNDERSTANDING HOW THESE ASPECTS OF CONSCIOUSNESS DEVELOP AND HOW THEY RELATE TO IDENTITY AND COGNITION.

FREE WILL AND DETERMINISM

DETERMINISM AND CAUSAL NECESSITY

DETERMINISM IS THE VIEW THAT EVERY EVENT, INCLUDING HUMAN ACTIONS, IS NECESSITATED BY PRECEDING EVENTS AND NATURAL LAWS. THIS PERSPECTIVE CHALLENGES THE NOTION THAT INDIVIDUALS CAN ACT OTHERWISE THAN THEY DO, RAISING DOUBTS ABOUT AUTONOMY.

COMPATIBILISM AND INCOMPATIBILISM

PHILOSOPHERS ARE DIVIDED BETWEEN COMPATIBILISTS, WHO ARGUE THAT FREE WILL CAN COEXIST WITH DETERMINISM, AND INCOMPATIBILISTS, WHO CLAIM THAT TRUE FREEDOM REQUIRES INDETERMINISM. THIS DISTINCTION SHAPES HOW FREEDOM AND RESPONSIBILITY ARE CONCEPTUALIZED.

LIBERTARIANISM AND INDETERMINISM

LIBERTARIANISM ASSERTS THAT FREE WILL EXISTS AND IS INCOMPATIBLE WITH DETERMINISM, OFTEN INVOKING INDETERMINISTIC ELEMENTS SUCH AS RANDOMNESS OR AGENT CAUSATION. THIS POSITION FACES CHALLENGES IN EXPLAINING HOW INDETERMINACY CAN PRODUCE RESPONSIBLE CHOICES.

PERSONAL IDENTITY AND THE SELF

PHILOSOPHICAL MYSTERIES ABOUT PERSONAL IDENTITY REVOLVE AROUND WHAT IT MEANS TO BE THE SAME PERSON OVER TIME DESPITE PHYSICAL AND PSYCHOLOGICAL CHANGES. THIS INQUIRY TOUCHES ON MEMORY, CONSCIOUSNESS, AND THE PERSISTENCE OF THE SELF.

THIS CLASSIC DILEMMA QUESTIONS WHETHER SOMETHING IS GOOD BECAUSE IT IS COMMANDED BY A DIVINE BEING OR IF THE DIVINE COMMANDS IT BECAUSE IT IS INHERENTLY GOOD. THE MYSTERY PROBES THE FOUNDATIONS OF MORAL OBJECTIVITY AND DIVINE AUTHORITY.

MORAL RELATIVISM VS. MORAL ABSOLUTISM

MORAL RELATIVISM HOLDS THAT MORAL TRUTHS DEPEND ON CULTURAL OR INDIVIDUAL PERSPECTIVES, WHILE MORAL ABSOLUTISM CLAIMS THAT CERTAIN ETHICAL PRINCIPLES ARE UNIVERSALLY VALID. THIS CONTRAST RAISES QUESTIONS ABOUT THE NATURE AND UNIVERSALITY OF MORAL VALUES.

PARADOXES OF MORAL DECISION-MAKING

Although Heidegger and other key philosophers have made a place for mystery in philosophy, many find such philosophizing suspect and unconvincing. As a general rule, contemporary philosophers have taken a different approach, and, thus, there has been very little discussion of mystery in philosophy. As a study of mystery in philosophy, this book is therefore somewhat unique.
