However, this estimate does not include the 3. 9 million residents of Puerto Rico, who are also U. S. citizens and would raise the total to 2 45. 2 million. This would make the U. S. population of Latinos the second-largest Spanish-origin population in the hemisphere, after Mexico. The growth of this population since 1980 has been dramatic. Hispanics/Latinos grew more than seven times faster than the population of the nation as a whole, increasing by half, whereas the white (non-Hispanic) population increased by only 6% between 1980 and 1990 (U.
