OVERVIEW OF SCID-5 VERSION FOR CLINICIANS

THE SCID-5 VERSION FOR CLINICIANS IS A SEMI-STRUCTURED INTERVIEW GUIDE DESIGNED TO ASSIST MENTAL HEALTH PROFESSIONALS IN DIAGNOSING DSM-5 PSYCHIATRIC DISORDERS RELIABLY AND SYSTEMATICALLY. IT IS AN UPDATED EDITION OF THE ORIGINAL SCID, REFLECTING REVISIONS IN DIAGNOSTIC CRITERIA INTRODUCED IN DSM-5. INTERVIEW PROCESS

THE CLINICIAN CONDUCTS THE INTERVIEW BY ASKING QUESTIONS VERBATIM FROM THE SCID-5 GUIDE, FOLLOWING THE BRANCHING LOGIC PROVIDED. RESPONSES ARE EVALUATED IN REAL-TIME TO DETERMINE WHETHER DIAGNOSTIC THRESHOLDS ARE MET. ADDITIONAL PROBING QUESTIONS MAY BE USED TO CLARIFY SYMPTOMS OR DURATION AS NEEDED.
