From the religious and imperial rivalry created by Charlemagne and the papacy to the genesis of French, English, German and then American Russophobia, the West has been engaged in more or less violent hostilities against Russia for a thousand years. The politician's strategy for winning this war was stated most succinctly by that arch media manipulator, David Lloyd George: what you can't square, you squash; and what you can't squash, you square. The media for their part, are determined to be neither squashed nor squared.
