These mothers step in to help with childcare and finances. Furthermore, mothers are overwhelmingly, according to military studies, the ones providing mental and physical healthcare when veterans need it. War provides mothers a way to participate in the national project, but the uneven burden of being a constant "supporter" further marginalizes their citizenship.
