When the law was codified in 1972, it was meant to deal with inequities in employment for women at institutions of higher education. In 46 years, Title IX has evolved into legislation that requires institutions of higher education to investigate and adjudicate allegations of sexual discrimination, sexual misconduct and sexual assault. Partly as a result of limited and varying guidance by the United States Department of Education, institutions of higher education are making errors in Title IX investigations that involve investigative technique and due process issues. The result is an increase in litigations directed towards those institutions. The main question in this mixed methods study investigated whether Title IX coordinators, investigators, and adjudicators have been adequately trained in investigative technique and due process issues in order to conduct or adjudicate Title IX investigations. Participants in the study were Title IX coordinators, investigators, and adjudicators who were interviewed or surveyed about their training experience. Data were analyzed using descriptive statistics, frequency tables, Spearman's correlations, t-tests and ANOVAs along with qualitative analysis which revealed themes in the data. The results revealed a lack of training for both areas of Title IX training. The results should lead to changes by institutions of higher education in Title IX training for their personnel.

I conducted semi-structured qualitative interviews with 35 Title IX coordinators across the United States (including both K-12 environments, as well as higher education). Participants represented 18 states, including urban, rural, and suburban environments. Interview transcripts were coded for thematic meaning. Five types of training practices were identified: training from one's professional background, self-guided reading, network of colleagues, episodic training, and little or no training at all. They identified five primary barriers to their ability to obtain stronger training: geographic location, employee turnover, expenses of training, training availability, and training quality as barriers to their professional growth. The data reveal a need for higher quality and more consistent training to prepare Title IX coordinators to address gender-based violence on school campuses. Recommendations for the removal of barriers include: stronger guidance from the Department of Education, increase of funding for Title IX professional development, and unity among Title IX coordinators who can advocate for better training and preparation to do their work.
