UNDERSTANDING THE VB-MAPP FRAMEWORK

THE VB-MAPP IS A CRITERION-REFERENCED ASSESSMENT TOOL DESIGNED TO EVALUATE THE VERBAL BEHAVIOR AND RELATED SKILLS OF CHILDREN, PRIMARILY TARGETING THOSE WITH LANGUAGE DELAYS OR AUTISM SPECTRUM DISORDER. IT CONSISTS OF THREE PRIMARY COMPONENTS: THE MILESTONES ASSESSMENT, THE BARRIERS ASSESSMENT, AND THE TRANSITION ASSESSMENT. EACH COMPONENT SERVES A UNIQUE PURPOSE IN IDENTIFYING A CHILD'S CURRENT SKILL LEVEL, POTENTIAL LEARNING OBSTACLES, AND READINESS FOR MAINSTREAM EDUCATIONAL SETTINGS. THE ASSESSMENT IS BASED ON B.F. SKINNER'S ANALYSIS OF VERBAL BEHAVIOR AND INTEGRATES APPLIED BEHAVIOR ANALYSIS (ABA) PRINCIPLES.

FAMILIARITY WITH THE STRUCTURE AND PURPOSE OF EACH VB-MAPP COMPONENT IS ESSENTIAL TO UNDERSTANDING THE SIGNIFICANCE OF VB-MAPP ASSESSMENT EXAMPLES. THESE EXAMPLES ILLUSTRATE HOW REAL CHILDREN'S RESPONSES AND BEHAVIORS ARE SCORED AND INTERPRETED TO DEVELOP INDIVIDUALIZED EDUCATIONAL AND BEHAVIORAL PLANS.

EXAMPLES OF VB-MAPP MILESTONES ASSESSMENT

THE MILESTONES ASSESSMENT EVALUATES 170 MILESTONES ACROSS 16 KEY SKILL AREAS, SUCH AS MANDING (REQUESTING), TACTING (LABELING), INTRAVERBALS (CONVERSATIONAL SKILLS), LISTENER SKILLS, AND SOCIAL INTERACTION. THIS SECTION DEMONSTRATES PRACTICAL VB-MAPP ASSESSMENT EXAMPLES THAT SHOW HOW SPECIFIC SKILLS ARE MEASURED.

MAND SKILLS EXAMPLE

One common vb-mapp assessment example in the manding category involves assessing a child's ability to request preferred items or activities using appropriate communication methods. For instance, a child may be presented with a desired toy and prompted to request it verbally or through alternative communication systems such as sign language or picture exchange. The child's response is scored based on independence and accuracy.

TACT SKILLS EXAMPLE

In tacting, an example might involve showing the child a picture of an apple and asking, "What is this?" The child's ability to correctly label the item demonstrates tacting skills. Scoring considers whether the response is spontaneous, prompted, or absent, providing insight into the child's expressive vocabulary development.

LISTENER SKILLS EXAMPLE

LISTENER SKILLS ARE ASSESSED BY OBSERVING HOW WELL A CHILD FOLLOWS INSTRUCTIONS WITHOUT REQUIRING VERBAL RESPONSES. AN EXAMPLE INCLUDES ASKING THE CHILD TO "PUT THE BLOCK IN THE BOX." THE CHILD'S ABILITY TO COMPLY WITH THIS DIRECTION WITHOUT PROMPTS IS RECORDED, REFLECTING RECEPTIVE LANGUAGE AND COMPREHENSION.

- MAND: REQUESTING ITEMS OR ACTIVITIES
- TACT: LABELING OBJECTS OR ACTIONS
- INTRAVERBAL: ANSWERING QUESTIONS OR CONVERSATIONAL EXCHANGES
- LISTENER SKILLS: FOLLOWING INSTRUCTIONS
- Social Interaction: Engaging with Peers or adults

EXAMPLES OF VB-MAPP BARRIERS ASSESSMENT

THE BARRIERS ASSESSMENT IDENTIFIES OBSTACLES THAT IMPEDE LEARNING AND DEVELOPMENT, SUCH AS PROMPT DEPENDENCY, BEHAVIOR PROBLEMS, OR DIFFICULTIES WITH IMITATION. THIS SECTION PROVIDES VB-MAPP ASSESSMENT EXAMPLES THAT ILLUSTRATE COMMON BARRIERS AND HOW THEY ARE DOCUMENTED.

PROMPT DEPENDENCY EXAMPLE

A CHILD WHO REQUIRES REPEATED PROMPTS TO PERFORM TASKS MAY SHOW PROMPT DEPENDENCY. AN EXAMPLE INCLUDES A CHILD WHO ONLY COMPLETES A MATCHING ACTIVITY CORRECTLY WHEN PHYSICALLY GUIDED. THE ASSESSOR NOTES THE LEVEL OF PROMPTING NEEDED AND ASSESSES THE CHILD'S ABILITY TO PERFORM INDEPENDENTLY OVER TIME.

BEHAVIOR PROBLEMS EXAMPLE

BEHAVIORAL CHALLENGES SUCH AS TANTRUMS OR AGGRESSION ARE ALSO RECORDED IN THE BARRIERS ASSESSMENT. AN EXAMPLE IS A CHILD WHO EXHIBITS DISRUPTIVE BEHAVIOR DURING TRANSITIONS OR DEMANDS, WHICH INTERFERES WITH LEARNING. THE ASSESSMENT DETAILS THE FREQUENCY, INTENSITY, AND CONTEXT OF THESE BEHAVIORS TO INFORM INTERVENTION STRATEGIES.

IMITATION DEFICITS EXAMPLE

IMITATION IS A CRITICAL SKILL FOR LANGUAGE AND SOCIAL DEVELOPMENT. A VB-MAPP ASSESSMENT EXAMPLE MIGHT INCLUDE A CHILD'S DIFFICULTY IMITATING SIMPLE MOTOR ACTIONS SUCH AS CLAPPING HANDS OR POINTING. THE ASSESSOR RECORDS WHETHER THE CHILD IMITATES SPONTANEOUSLY, WITH PROMPTS, OR NOT AT ALL.

PROMPT DEPENDENCY LIMITING INDEPENDENT RESPONSES

EXAMPLES OF VB-MAPP TRANSITION ASSESSMENT

THE TRANSITION ASSESSMENT EVALUATES A CHILD'S READINESS TO MOVE INTO LESS RESTRICTIVE EDUCATIONAL ENVIRONMENTS, SUCH AS MAINSTREAM CLASSROOMS. THIS COMPONENT INCLUDES MEASURES OF ACADEMIC SKILLS, SOCIAL BEHAVIOR, AND INDEPENDENCE. THE FOLLOWING VB-MAPP ASSESSMENT EXAMPLES ILLUSTRATE KEY AREAS ASSESSED DURING TRANSITION PLANNING.

ACADEMIC SKILLS EXAMPLE

AN EXAMPLE OF ACADEMIC SKILL ASSESSMENT MIGHT BE A CHILD'S ABILITY TO IDENTIFY LETTERS, NUMBERS, OR COLORS. THE ASSESSOR TESTS RECOGNITION AND NAMING SKILLS, WHICH INDICATE READINESS FOR CLASSROOM LEARNING DEMANDS.

INDEPENDENCE EXAMPLE

INDEPENDENCE IN DAILY LIVING SKILLS, SUCH AS FOLLOWING A SCHEDULE OR COMPLETING TASKS WITHOUT ASSISTANCE, IS ANOTHER FOCUS. AN EXAMPLE INCLUDES A CHILD'S ABILITY TO TRANSITION BETWEEN ACTIVITIES WITH MINIMAL SUPPORT, REFLECTING THEIR ADAPTABILITY TO CLASSROOM ROUTINES.
