The Constitution's structures and norms are set out, and the sharing of power with courts and other polities examined. It is a vivid and compelling snapshot of the United States as a federalist system of powerful and proud states and localities--at a time when they were perceived, even after a bloody war to preserve the federal Union, as independent and functional in their own realms, and not some convenient geographic subdivision of a singular nation.
