UNDERSTANDING THE FINAL WALKTHROUGH

THE FINAL WALKTHROUGH IS THE LAST OPPORTUNITY FOR BUYERS TO INSPECT THE PROPERTY BEFORE CLOSING. THIS STEP USUALLY TAKES PLACE SHORTLY BEFORE THE CLOSING DATE AND ALLOWS BUYERS TO CONFIRM THAT THE HOME IS IN THE CONDITION AGREED UPON IN THE PURCHASE CONTRACT. IT SERVES AS A FINAL CHECK TO ENSURE THAT THE PROPERTY IS READY FOR THE NEW OWNERS, FREE FROM ANY UNFORESEEN ISSUES OR DAMAGE.

TYPICALLY, THE FINAL WALKTHROUGH IS SCHEDULED WITHIN 24 TO 48 HOURS PRIOR TO CLOSING. THIS TIMEFRAME IS OFTEN SUFFICIENT TO ADDRESS ANY LAST-MINUTE CONCERNS AND ENSURES THAT BOTH THE BUYER AND SELLER ARE READY TO COMPLETE THE TRANSACTION. UNDERSTANDING THE PURPOSE AND PROCESS OF THE FINAL WALKTHROUGH IS ESSENTIAL FOR ALL PARTIES INVOLVED IN A REAL ESTATE TRANSACTION.

WHEN DOES FINAL WALKTHROUGH HAPPEN?

THE TIMING OF THE FINAL WALKTHROUGH IS CRITICAL AND GENERALLY OCCURS AFTER THE SELLER HAS VACATED THE PROPERTY BUT BEFORE THE CLOSING MEETING. IMPORTANCE OF THE FINAL WALKTHROUGH

THE FINAL WALKTHROUGH SERVES SEVERAL IMPORTANT PURPOSES IN THE HOME BUYING PROCESS. IT IS A BUYER'S OPPORTUNITY TO ENSURE THAT THE PROPERTY MEETS THEIR EXPECTATIONS AND THAT ANY AGREED-UPON REPAIRS HAVE BEEN COMPLETED. THE SIGNIFICANCE OF THIS STEP CANNOT BE OVERSTATED FOR THE FOLLOWING REASONS:

- **VERIFICATION OF CONDITION:** THE WALKTHROUGH ALLOWS BUYERS TO CONFIRM THAT THE HOME IS IN THE CONDITION THEY EXPECTED BASED ON THE PURCHASE AGREEMENT.
- **ASSESSMENT OF REPAIRS:** IF REPAIRS WERE PROMISED BY THE SELLER, THE FINAL WALKTHROUGH IS THE TIME TO ENSURE THEY HAVE BEEN COMPLETED SATISFACTORILY.

- THE CONDITION OF FENCES OR WALLS SURROUNDING THE PROPERTY.

IT'S ALSO WISE TO CHECK FOR ANY SIGNS OF PEST INFESTATIONS OR WATER DAMAGE. BUYERS SHOULD TAKE THEIR TIME DURING THE WALKTHROUGH TO ENSURE THEY ADDRESS ANY CONCERNS BEFORE CLOSING.

BEST PRACTICES FOR A SUCCESSFUL FINAL WALKTHROUGH

TO ENSURE A SMOOTH FINAL WALKTHROUGH, BUYERS CAN FOLLOW SEVERAL BEST PRACTICES:

- BRING A CHECKLIST TO HELP REMEMBER WHAT TO INSPECT.
- SCHEDULE THE WALKTHROUGH AT A TIME WHEN LIGHTING IS OPTIMAL FOR VISIBILITY.
- CONSIDER BRINGING A TRUSTED FRIEND OR FAMILY MEMBER FOR AN ADDITIONAL PERSPECTIVE.
- DOCUMENT ANY ISSUES WITH PHOTOS AND NOTES FOR DISCUSSION WITH THE SELLER.

BY FOLLOWING THESE BEST PRACTICES, BUYERS CAN MAXIMIZE THE EFFECTIVENESS OF THEIR FINAL WALKTHROUGH AND FEEL MORE CONFIDENT MOVING FORWARD WITH THE CLOSING PROCESS.

COMMON ISSUES TO LOOK FOR

WHILE CONDUCTING THE FINAL WALKTHROUGH, BUYERS SHOULD BE VIGILANT ABOUT POTENTIAL ISSUES THAT MAY AFFECT THEIR DECISION TO PROCEED WITH THE CLOSING. SOME COMMON PROBLEMS TO LOOK FOR INCLUDE:

- INCOMPLETE REPAIRS THAT WERE PROMISED BY THE SELLER.
- SIGNS OF WATER DAMAGE OR MOLD.
- MISSING APPLIANCES OR FIXTURES THAT WERE INCLUDED IN THE SALE.
- UNEXPLAINED CHANGES OR ALTERATIONS TO THE PROPERTY.

IF ANY SIGNIFICANT ISSUES ARISE DURING THE FINAL WALKTHROUGH, BUYERS SHOULD DISCUSS THEIR CONCERNS WITH THEIR REAL ESTATE AGENT IMMEDIATELY. THIS DIALOGUE CAN LEAD TO NEGOTIATIONS FOR REPAIRS OR ADJUSTMENTS IN CLOSING TERMS.

A: YOU SHOULD BRING A CHECKLIST OF ITEMS TO INSPECT, A CAMERA FOR DOCUMENTATION, AND ANY RELEVANT PAPERWORK RELATED TO THE SALE AND AGREED-UPON REPAIRS.

Q: WHAT HAPPENS IF THE SELLER FAILS TO MAKE AGREED-UPON REPAIRS?

A: IF THE SELLER FAILS TO MAKE AGREED-UPON REPAIRS, THE BUYER CAN NEGOTIATE FOR REPAIRS TO BE COMPLETED BEFORE CLOSING OR REQUEST A REDUCTION IN THE SALE PRICE TO ACCOUNT FOR THE COSTS OF REPAIRS.

Q: CAN I CANCEL THE SALE IF I FIND ISSUES DURING THE FINAL WALKTHROUGH?

A: DEPENDING ON THE SEVERITY OF THE ISSUES FOUND, BUYERS MAY HAVE THE OPTION TO CANCEL THE SALE, ESPECIALLY IF IT VIOLATES THE TERMS OF THE PURCHASE AGREEMENT. IT'S ESSENTIAL TO CONSULT WITH YOUR AGENT AND ATTORNEY IN SUCH CASES.

Q: IS IT COMMON FOR BUYERS TO REQUEST REPAIRS AFTER THE FINAL WALKTHROUGH?

A: IT IS RELATIVELY COMMON FOR BUYERS TO REQUEST REPAIRS AFTER THE FINAL WALKTHROUGH IF SIGNIFICANT ISSUES ARE IDENTIFIED, BUT THIS TYPICALLY DEPENDS ON THE TERMS OF THE PURCHASE AGREEMENT AND THE NATURE OF THE ISSUES. CONSULTING WITH A REAL ESTATE PROFESSIONAL CAN PROVIDE GUIDANCE ON HOW TO PROCEED.
