ICE FISHING IS ANOTHER ENGAGING PUZZLE WHERE YOU MUST CATCH FISH TO GATHER CLUES. PAY ATTENTION TO THE FISHING TECHNIQUE, AS DIFFERENT TYPES OF FISH REQUIRE DISTINCT METHODS. BE PATIENT AND PRACTICE, AS THIS MINI-GAME CAN BE TRICKY BUT REWARDING.
